5 A RESOLUTION

6 **Laying out, opening and establishing as part of the City street system a parcel**
7 **of land as South Jay Street between West Amherst Avenue and West Bates**
8 **Avenue.**

10 **WHEREAS**, the Manager of Public Works of the City and County of Denver has found and
11 determined that the public use, convenience and necessity require the laying out, opening and
12 establishing as public streets designated as part of the system of thoroughfares of the municipality
13 those portions of real property hereinafter more particularly described, and, subject to approval by
14 resolution has laid out, opened and established the same as a public street;

15 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**

18 **Section 1.** That the action of the Manager of Public Works in laying out, opening and
19 establishing as part of the system of thoroughfares of the municipality the following described
20 portion of real property situate, lying and being in the City and County of Denver, State of
21 Colorado, to wit:

25 A parcel of land conveyed by Warranty Deed to the City & County of Denver, Recorded
26 on the 25th of November 1961, in Book 8767 Page 147, in the City & County of Denver
27 Clerk and Recorder's Office, State of Colorado. Located in Section 36, T.4S., R.69W.,
28 of the 6th P.M.,

29 That portion of land located adjacent to the northeast corner of Lot 11, Block 15, in Bear
30 Valley Subdivision described as follows: Beginning at the aforementioned corner; thence
31 northwesterly along the northeast property line a distance of 2.5 feet; thence on an angle
32 to the left of 135°38'04" a distance of 3.58 feet more or less to a point located on the
33 southeast property line of said Lot 11; thence northeasterly along said property line a
34 distance of 2.5 feet more or less to the point of beginning, said described portion of land
35 contains 3.12 square feet.
