- BR14-1094 Rezones Block 1 of the South Sloan's Lake Subdivision Filing No. 1 located at the southeast corner of 17th Avenue and Stuart Street from C-MX-5/DO-5\* (Urban Center, Mixed Use, 5 stories, Design Overlay Sloans Lake) to C-MX-12/DO-5\* (Urban Center, Mixed Use, 12 stories, Design Overlay Sloans Lake) in Council District 1.
- BR14-1095 Rezones property at 1673 South Emerson Street from U-SU-B (Urban, Single Unit, 4,500 lot size) to U-SU-B1 (Urban, Single Unit, 4,500 lot size, Accessory Dwelling Unit) in Council District 7.
