FIRST AMENDMENT TO AIRPORT USE AND FACILITIES LEASE AGREEMENT

This First Amendment to Airport Use and Facilities Lease Agreement is made and entered into as of this ______ day of ______, 2011, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado ("the City"), and LUFTHANSA GERMAN AIRLINES, a corporation organized and existing under and by virtue of the laws of the country of Germany, and authorized to do business in the State of Colorado ("Airline"), Party of the Second Part.

WHEREAS, the City and Airline have previously entered into an Airport Use and Facilities Lease Agreement at Denver International Airport ("DIA"), dated August 8, 2006 ("Existing Agreement");

WHEREAS, City and Airline desire to further modify the Existing Agreement to create a first amended agreement ("Amended Agreement");

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements, herein contained, City and Airline do hereby mutually undertake, promise and agree, each for itself and its successors, as follows:

- 1. Exhibit D-1, attached hereto, replaces Exhibit D of the Existing Agreement, effective on the dates specified in the attached revised Exhibit D-1.
- Paragraph 6.01, "TERM OF AGREEMENT," of the Existing Agreement is deleted in its entirety and replaced with the following:




- Except as otherwise modified or amended herein, all terms and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.




