Executive Summary

The request is to approve a capital lease with All American Investment Group, LLC for turf equipment to be used by Denver Parks and Recreation and Golf Enterprise. The lease will close soon after the ordinance passes and continue until October 15, 2016 at which point final payment of the lease will constitute purchase of the equipment. The total principal amount is \$2,151,525. Interest will be 1.80% with annual payments approximately \$452,000. Total purchase price is not to exceed \$2,260,000.

This bill request is accompanied by a "zero dollar contract" request for a contract with the equipment supplying vendor, C & M Golf Equipment. All American Investment Group will purchase the equipment, after which the City will lease the equipment through 2016.
