10 For an ordinance amending Chapter 2, Article VIII, Division 11 of the Denver Revised
11 Municipal Code to transfer governance of the Crime Prevention and Control
12 Commission from the Department of Safety to the Department of Human Services.
13

14 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That paragraph 2-255.49(a)(2), D.R.M.C. shall be amended by deleting the
16 language stricken and adding the language underlined, to read as follows:

17• **Sec. 2-255.49. - Commission created.**

18 There is hereby created a crime prevention and control commission. The
19 members of the commission should reflect the diversity of Denver, including the
20 ethnic, racial, and geographic constitution of the population as well as the diverse
21 professional backgrounds, experience, and expertise of the citizens of Denver. The
22 commission shall consist of thirty-one (31) members as follows:

23 (a) The following twelve (12) officers or the officer's designated
24 representative:

25 (2) The manager of ~~safety~~ human services.

28 **Section 2.** That section 2-255.57, D.R.M.C. shall be amended by deleting the language
29 stricken and adding the language underlined, to read as follows:
30

31 **Sec. 2-255.57. - Staffing and administrative support.**

1 Staffing and other administrative support for the crime prevention and control
2 commission shall be provided by the department of ~~safety~~ human services. The
3 manager of ~~safety~~ human services shall appoint an executive director for the
4 commission, after consultation with the commission. The executive director shall not
5 be removed unless and until the manager consults with the commission regarding the
6 removal.
