## Dangers of Street Racing

- Serious road safety concern for participants, observers, and uninvolved passersby
- Concern related to:
  - High-speed crashes
  - Driving while impaired
  - Other criminal activity including recovered guns and drugs

#### Denver Police Continues to Warn Drivers on the Dangers and Consequences of Street Racing

Denver – Friday, March 19, 2021 – With the warm weather predicted this weekend, the Denver Police Department is again reminding drivers and passengers of the dangers of speed contests and illegal drag racing events. Drag racing continues to be a safety concern for motorists as high speeds increase the likelihood of injury and death in crashes. Additionally, large gatherings where these occur can result in other crimes and violence. There are several consequences of drag racing, including the impounding of vehicles.

An example of drag racing occurred on February 6, 2021, when a Denver Police officer assigned to Traffic Operations was proactively patrolling on 1-25 near Downing Street. There he witnessed two vehicles slow their speeds to approximately 45 miles per hour (MPH) in a 60 MPH zone. Both drivers quickly accelerated, and the officer clocked one of the vehicles traveling at 108 MPH. He safely pulled the 25-year-old male driver over and cited him for drag racing. Then, the vehicle was detained under Denver's Public Nuisance Abatement Ordinance, and will be held until August of 2021.

"Between January 1, and March 17, 2021, Denver Police officers cited 17 drivers for drag racing" said Police Chief Paul M. Pazen. "Drag racing is extremely dangerous and has very serious consequences. Those who engage in drag racing risk losing their drivers' licenses with the 12-point traffic violation, fines up to \$999 and having their vehicle impounded."

The Denver Police Department continually monitors for street racing events, and for several months has dedicated resources – now including its helicopter – to disrupting the gatherings, while enforcing traffic and criminal offenses.
