Proclamation No. 13-0246

Designating the Week of April 14-20, 2013 in Denver as NATIONAL PUBLIC SAFETY TELECOMMUNICATIONS WEEK

WHEREAS, emergencies can occur at anytime that require police, fire and/or medical services; and

WHEREAS, when an emergency occurs the prompt response of police officers, firefighters and paramedics is critical to the protection of life and the preservation of property; and

WHEREAS, the safety of our police officers and firefighters is dependent upon the quality and accuracy of information obtained from citizens who telephone Denver 911; and

WHEREAS, Emergency Communications Operators are the first and most critical contact our citizens have with emergency services; and

WHEREAS, Public Safety Dispatchers are the single vital link for our first responders by monitoring their activities by radio, providing them information and insuring their safety; and

WHEREAS, Denver 911 Police Dispatchers have contributed substantially to the apprehension of criminals, suppression of fires, and treatment of patients; and

**NOW THEREFORE,
BE IT PROCLAIMED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

Section 1. That the Denver City Council designates the Week of April 14-20, 2013 as National Public Safety Telecommunications Week in the City and County of Denver and recognizes and congratulates the Denver 911 2012 Employee of the Month winners and the Denver 911 2012 Employee of the Year – Brian McGlawn - for their outstanding contributions to the City and County of Denver.

Section 2. That the Clerk of the City and County of Denver shall attest and affix the seal of the City and County of Denver to this proclamation and that copies be transmitted to Denver's Department of Safety and to the 2012 Employee of the Month recipients.
