## **EXECUTIVE SUMMARY**

Ordinance request approving a contract with Ballet Nouveau Colorado, THTRS-201207018

This ordinance will approve a contract with Ballet Nouveau Colorado, THTRS-201207018. Ballet Nouveau will manage performers for the Carry On Live Performance at the Ellie Caulkins Opera House on September 7, 2012.

This agreement between the Parties creates a revenue sharing opportunity for the City & County of Denver, Arts & Venues Denver whereby the Contractor accepts, as the sole compensation for services rendered and costs incurred under this Agreement, an amount equal to seventy percent (70%) of Gross Gate Receipts (as hereinafter defined) from ticket sales for the Event. The City shall receive an amount equal to thirty percent (30%) of Gross Gate Receipts from ticket sales for the Event. For purposes of this Agreement, "Gross Gate Receipts" shall mean the difference between all proceeds generated from ticket sales for the Event and the associated marketing and promotion costs and expenses, house costs, and ticketing costs.

Estimated ticket sales (revenue) are \$70,000.00 less marketing and promotion expenses of \$3,000.00, houses costs of \$11,000.00, and \$4,500.00 ticketing costs are equal to a net revenue of \$51,500.00 which will serve as the qualifying amount for the 70/30% split.
