Central Student Transportation ("CST") provides transportation services for individuals experiencing homelessness. Transportation routes are available to riders from 8:30am to 3:30pm Monday through Fridays ("Circular Route"), during inclement weather events, and as part of other street outreach or housing related efforts. Reporting expectations include monthly tracking of riders per trip, riders utilizing each stop, departure, and arrival times. CST and HOST also meet monthly to discuss success and challenges.

**Scope of work:**

**SERVICES DESCRIPTION**

- A. CST will provide bus transportation to individuals experiencing homelessness Monday thru Friday (or as specified by HOST) through the term of this contract using transit buses.
- B. Service Area: Designated origin and end transit stops generally located within five (5) miles from central downtown Denver between 8:30 a.m. and 5:30 p.m. but may be expanded based on service coverage demands as determined by HOST. Starting locations are in central downtown Denver and ending locations are in the vicinity of I-70 and Colorado Boulevard.
- C. Primary transportation services include but are not limited to:
  - 1. A “Circular Route” to provide system-wide transportation services between shelters.
  - 2. “Newcomers” transportations services as part of existing or emerging city-wide responses.
  - 3. Inclement weather transportation services.
  - 4. Other transportation services as determined by HOST related to street outreach or housing efforts.
- D. Accessibility: CST will provide ADA accessible vehicles for individuals in wheelchairs or with other mobility impairments.
- E. Capacity: Transportation will allow for approximately 150 people during the time frames specified for the circular route and ridership demand for other services.
- F. Safety: All buses will have a camera and audio to monitor activities on the bus.
- G. CST must have a contingency plan that includes notification to HOST management, shelter locations and clientele if they cannot run routes and/or individual buses and if routes and/or individual buses are running late.
