CURRENT BOARD STATUS

Scope of Board/Commission: The Santa Fe BID was created in 2015 for the purpose of implementing new and improved services through a special tax assessment for the Santa Fe Drive commercial corridor between the 600 and 1200 blocks. These services include Physical Improvements, Maintenance, Economic Development, and Safety.

Appointment Process: Mayor appoints 11 members (was recently increased from 7) to this board followed by City Council Confirmation
