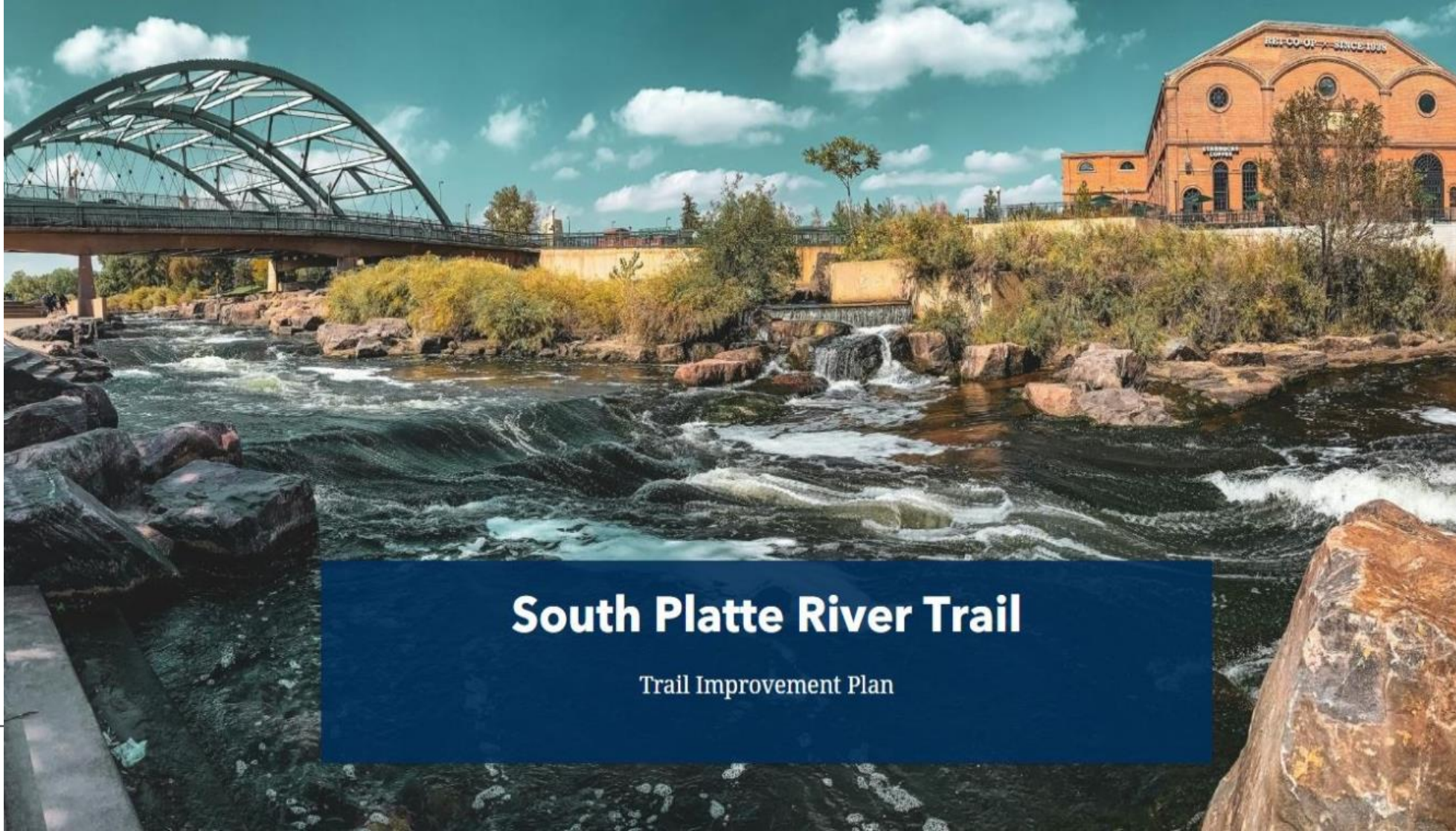

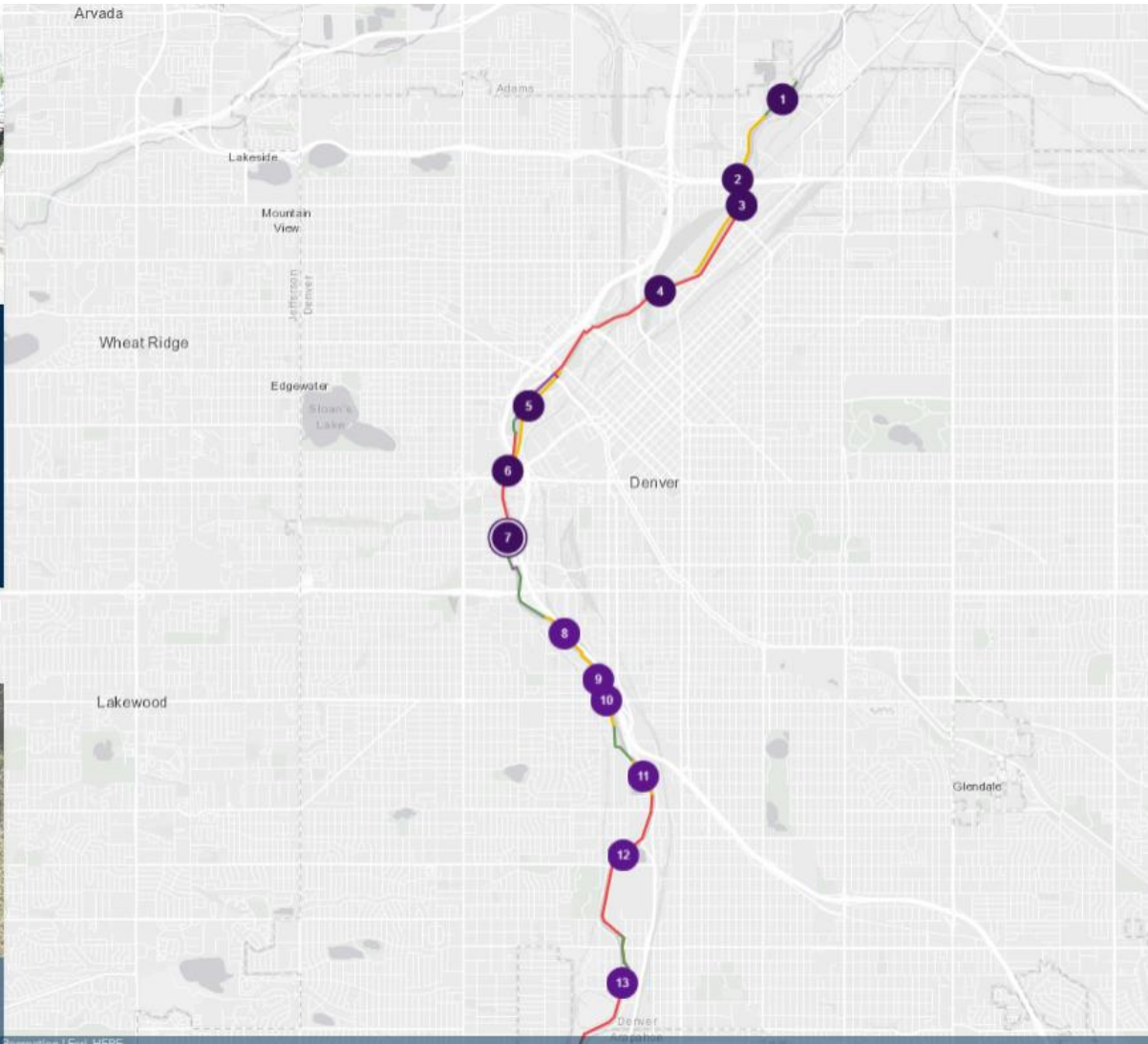


Sun Valley (11th Ave to Weir Gulch Trail)

The trail will be upgraded to the regional standard in conjunction with the development of a new Sun Valley Riverfront Park. Construction is anticipated to begin in 2025. Please check back for updates and news about impacts to trail users as they are implemented.

24-0886 - AMENDS AN INTERGOVERNMENTAL AGREEMENT WITH THE DENVER HOUSING AUTHORITY (DHA)

Action Request: Approves...

-The addition of \$2,000,000 in Elevate Bond Funds

- The addition of \$1,000,000 in DPR CIP Funds

- Along with DHA funding for a total project budget of \$8,500,000 to construct ~4.5 acres of the first phase for a riverfront park, which includes trail connections to the South Platte River Trail and the Weir Gulch Trail

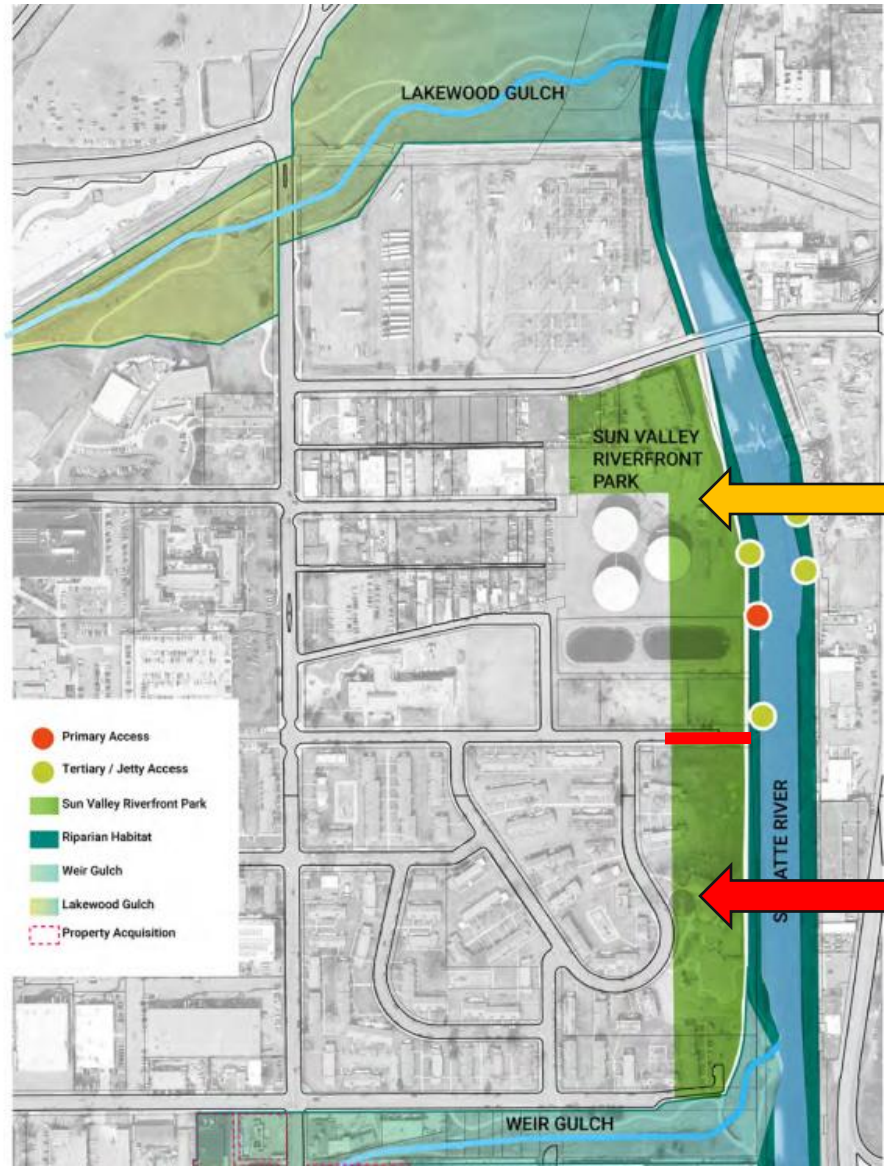
Relationship to Surrounding Open Space Network and Waterways

ADJACENT OPEN SPACE AND TRAIL ACCESS

Sun Valley Riverfront Park is an important part of the surrounding open space network and waterways. The park will be an active destination with direct access to the larger regional trail network along the South Platte River, Lakewood and Weir Gulch.

The water and drainage functions of Weir Gulch and the South Platte River are also an opportunity to feature the sustainability goals of Sun Valley, enhance the natural ecology, improve water quality/riparian habitat, and celebrate role water plays as a part of the Colorado River watershed.

New river access points, overlooks, and trails can provide new opportunities to interact with the water and engage with the natural river habitat and riparian areas.

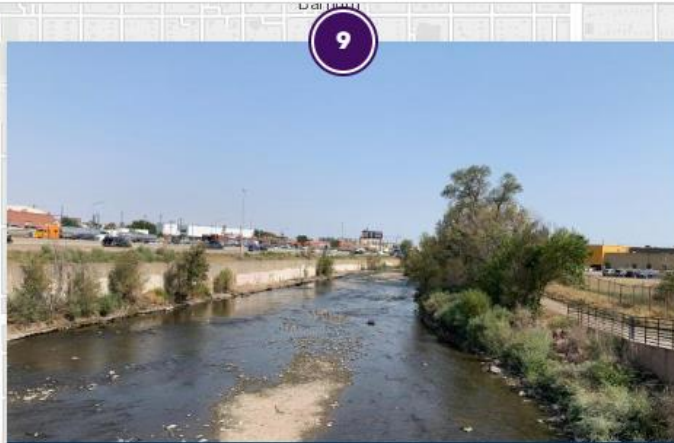

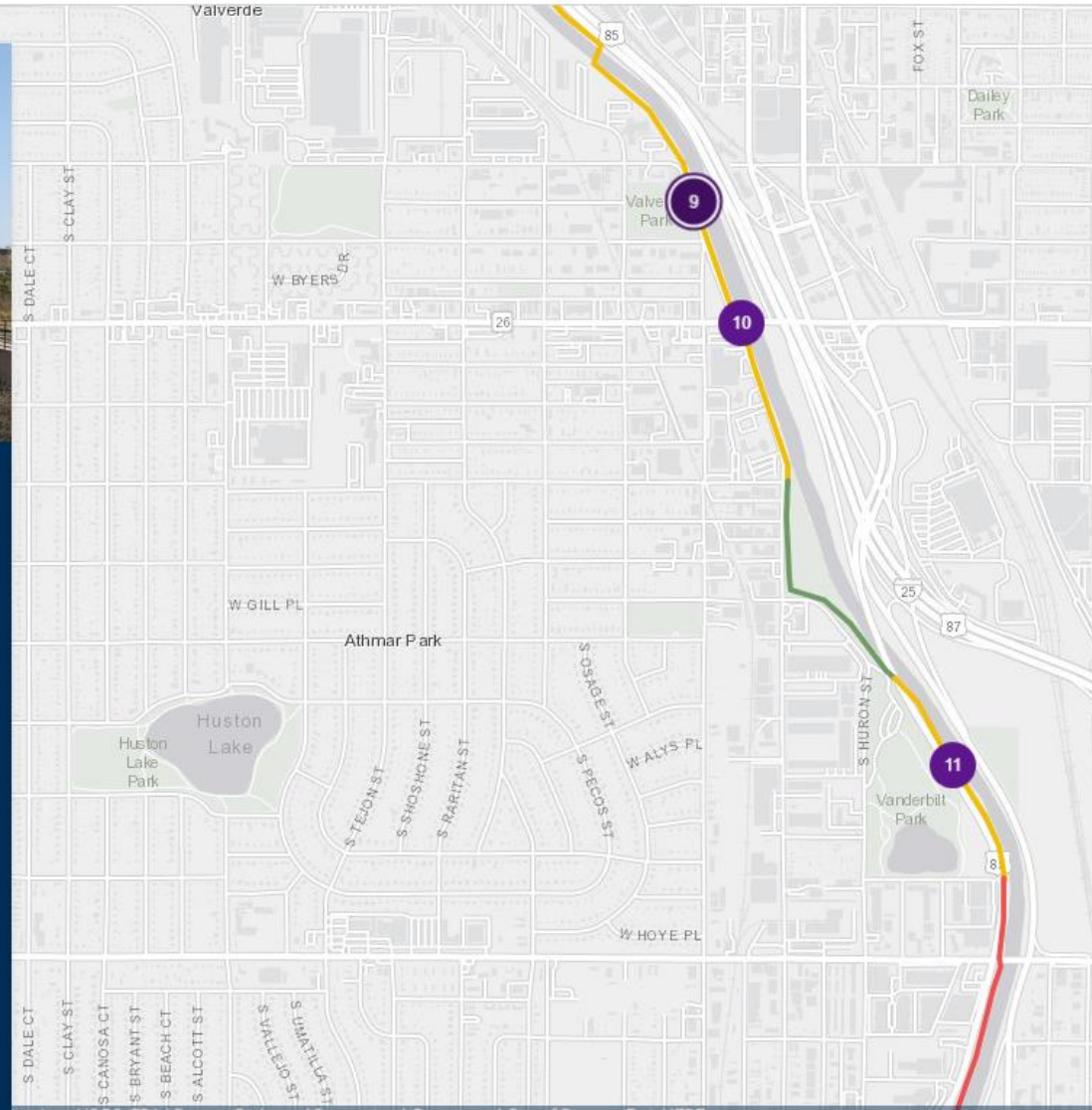

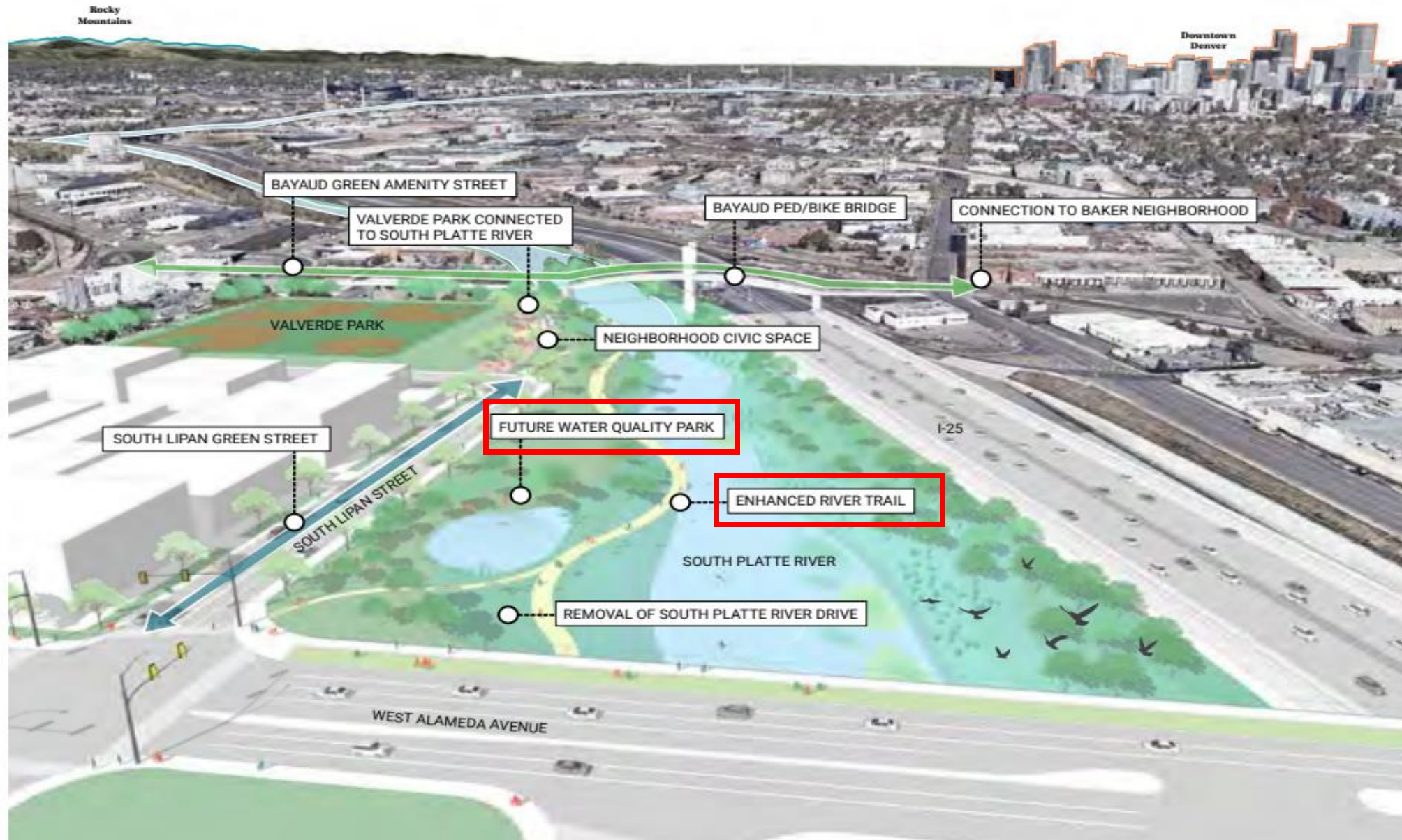
Virginia to Bayaud Avenue

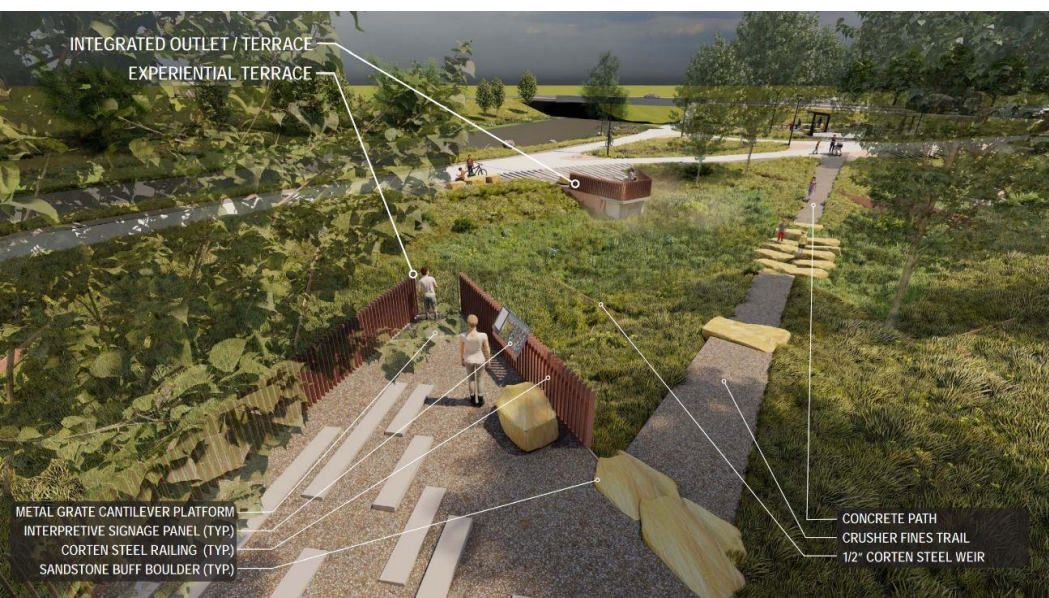
This project will widen and improve the existing South Platte River Trail to meet Denver Parks and Recreation's new regional trail standard of a 12-foot-wide concrete trail and an adjacent 4-foot wide crusher fines trail. The project will also include trail lighting, a new trailhead, and will realign South Platte River Drive to improve trail safety and comfort.

Construction is anticipated to begin in summer 2024 and you can find out more

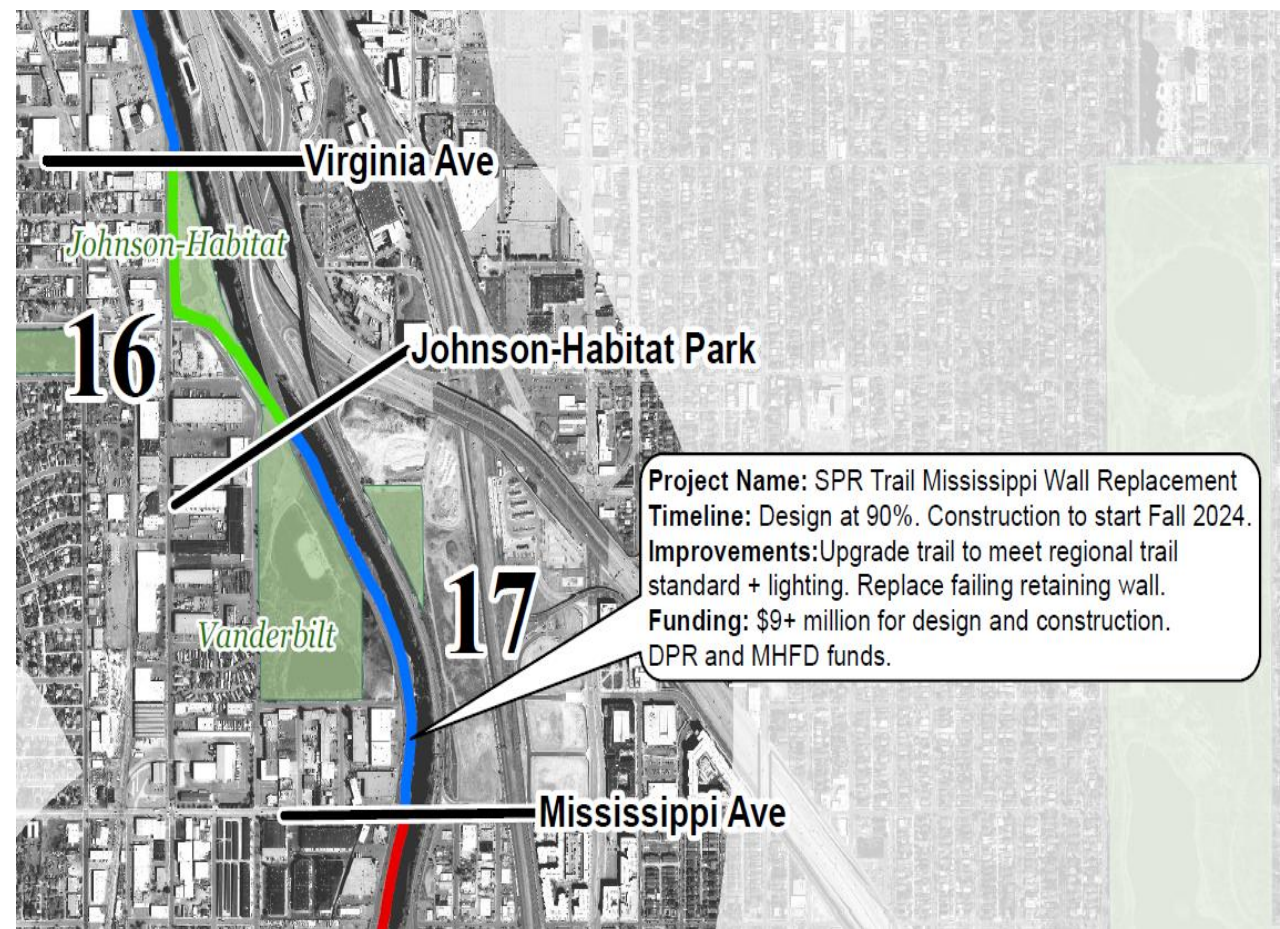

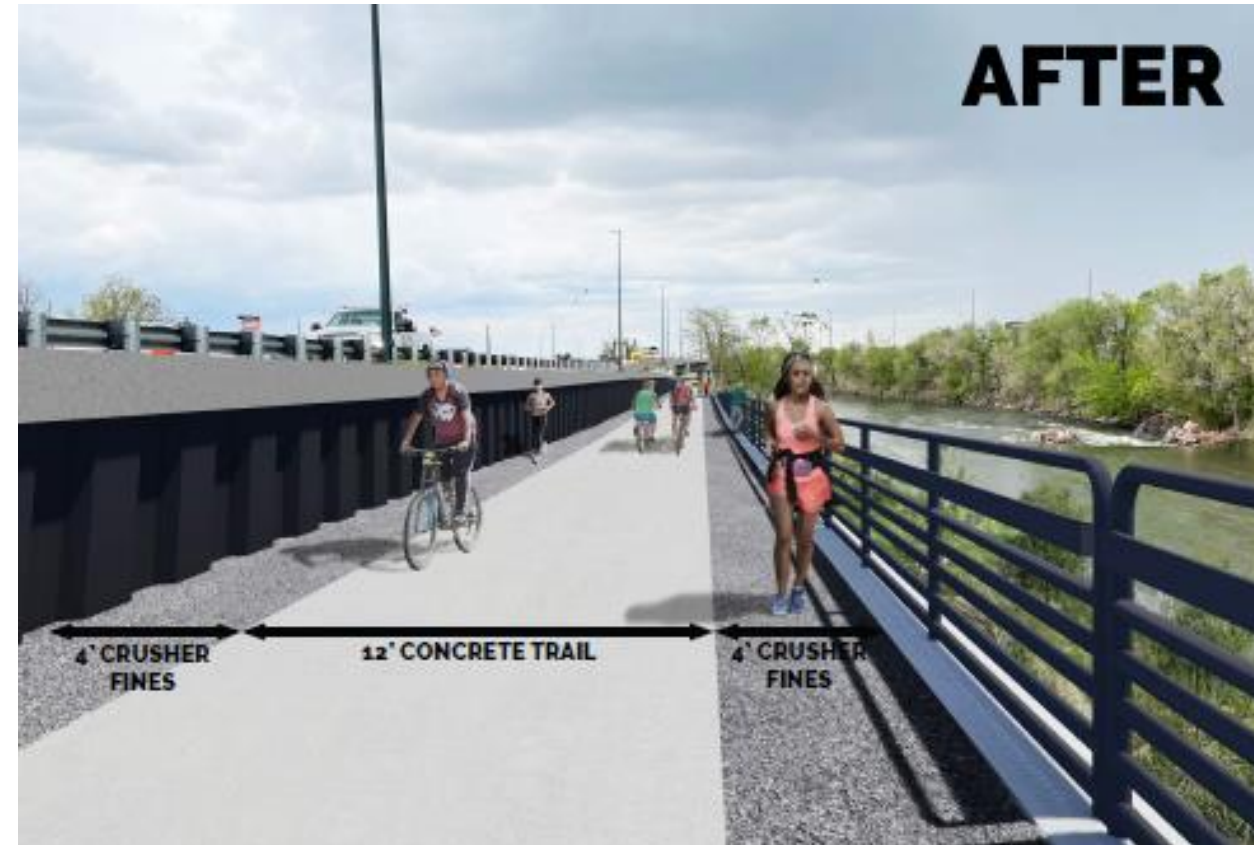
