**A BILL**

**For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado concerning the "Promoting Safe and Stable Families (PSSF)" program and the funding therefor.**

**WHEREAS**, the State of Colorado has tendered to the City a Grant award for the "PSSF" program; and

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement, under CFDA No. 93.556, between the State of Colorado and the City and County of Denver, which is identified as Grant Number CMS 56369, a copy of which is duly filed with the City Clerk, Filing No. 12-0516-A, be and hereby is approved in all respects.

**Section 2.** The payments made by the State of Colorado to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said "PSSF" Program, Accounting No. 13001-5511101-H2142 is as follows, to be expended by the Manager of Human Services:

The foregoing authorization will provide funds to reduce barriers to children achieving permanency through adoption and reunification with family members. Authorization for expenditure of said funds following execution of said grant will cover the period from July 1, 2013 to June 30, 2014.

2 and directed to make such book and record entries and to do such other things as may be  
3 necessary to accomplish the purposes of this Ordinance.
