Description: Catholic Charities Denver is a 501(c)3 that is the charitable arm of the Archdiocese of

Denver. Since 1986, Catholic Charities Denver has been providing shelter, food, clothing and case management and supportive services to men, women and families experiencing homelessness. Catholic Charities Denver currently operates the Samaritan House shelter, which provides 127,000 nights of shelter and 455,000 meals each year to individuals, families, and children in need in Denver. Programs offered at the Samaritan House shelter include the Holy Rosary Center for Women program which offers shelter and

services for single women experiencing homelessness.

The financing request is for \$1,000,000 of CDBG funds to acquire an existing building at 6240 Smith Road, Denver, CO 80216. Catholic Charities Denver will finance the remainder of the \$2,500,000 purchase price with its own funds. Catholic Charities Denver will also use its own funds to renovate the two-story building to provide 100 overnight shelter beds and 50 30-day transitional housing beds for women on the first floor; and space for case management and supportive services on the second floor. Women will have access to services and amenities at both the new shelter and at Samaritan House. The funds will be disbursed as a loan with repayment deferred and forgiven after 7 years unless the property is refinanced, sold, or changes in use.

This project fulfills the CDBG National Objective of serving a low- and moderate-income clientele, including facilities that serve clients experience homelessness.
