Wende Sherwood Reoch is a 20 year resident of Denver, retired after a career in public broadcast management and university advancement. She managed the operations of WUSF-FM, the NPR affiliate in Tampa, Florida for 15 years and upon moving to Colorado, she spent 5 years at CU Health Sciences Center as the Director of Alumni Relations, supporting their development arm, the CU Foundation, and managing the programs, communications and budgets of their Alumni Relations including its four individual boards of directors.

Over the course of her professional career and then in her community work after retirement, she specialized in:

- revamping strategic plans and policies to increase the productivity of an organization or board, and enhance its transparency and responsiveness to customers and/or community.
 A colleague described her work as "making order out of chaos."
- small and large project review management including the design, equipping and operational management of a state-of-the-art radio facility.
- understanding the unique relationship a public institution has with its constituents and its responsibility to be accountable to the trust they have given.

As a volunteer, Wende has devoted her energies to support her passion for the environment including leadership positions in the Sierra Club (in Tampa and Denver), advocating for sustainable development in urban planning on Denver's NPI East Area Plan Steering Committee and in her neighborhood RNO, the Cranmer Park/Hilltop Civic Association. She served on the Denver Parks & Recreation Advisory Board until 2019 and was a member of the Budget Committee during her three years on PRAB.
