**A BILL**

**For an ordinance authorizing a capital equipment purchase from the Risk Management Fund (SRF 11838) Fund for Denver Parks and Recreation.**

**WHEREAS**, the Department of Park and Recreation (DPR) is seeking approval for a capital equipment purchase of a vehicle to be used for maintenance and operation of parks, including grounds, structures, and related equipment; and

**WHEREAS**, said vehicle is a replacement of a City-owned vehicle that was in an auto accident and determined as totaled; and

**WHEREAS**, said replacement vehicle purchase is authorized to be paid from out of the Department of Finance (DOF), Risk Management Special Revenue (11838); and

**WHEREAS**, because this is a capital equipment purchase above the fifty-thousand dollars threshold, DPR requires City Council authorization to purchase said vehicle;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Risk Management Special Revenue Fund, Accounting No. (11838), the Chief Financial Officer, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:

The foregoing vehicle purchase is to support the operations of the Department of Parks and Recreation.
