

**FOURTH AMENDMENT TO
FUEL SYSTEM MAINTENANCE, OPERATION
AND MANAGEMENT SERVICES AGREEMENT**

THIS FOURTH AMENDMENT TO FUEL SYSTEM MAINTENANCE, OPERATION AND MANAGEMENT SERVICES AGREEMENT (the “**Fourth Amendment**”) is to be effective from and as of the date stated on the City’s signature page below, among the **CITY AND COUNTY OF DENVER**, a municipal corporation and home rule city organized and existing under the Constitution and laws of the State of Colorado (the “**City**”), **AIRCRAFT SERVICE INTERNATIONAL, INC.**, a Delaware corporation authorized to do business in the State of Colorado (“**ASI**” or the “**Operator**”), and the **CONTRACTING AIRLINES** (as defined in the “**MOMS Agreement**” defined and described in the Recitals below) (all of the foregoing are referred to herein as the “**Parties**”).

RECITALS

WHEREAS, all of the Parties are parties to the “Fuel System Maintenance, Operation and Management Services Agreement” entered into as of the third day of March, 1999, which was amended by a Revival and First Amendment dated April 25, 2006, a Second Amendment executed March 3, 2009, and a Revival and Third Amendment dated June 2, 2014 (collectively the existing “**MOMS Agreement**”); and

WHEREAS, the Parties desire to enter into this Fourth Amendment to the MOMS Agreement as provided herein;

AGREEMENT

NOW THEREFORE, in consideration of the foregoing recitals, other valuable consideration, receipt of which is hereby acknowledged, and in consideration of the mutual conditions and obligations set forth herein, the Parties agree as follows:

ARTICLE I AMENDMENTS

1.1 Management Fee. Section 4.01(a)(c) of the MOMS Agreement is hereby amended by deleting the reference to “**February 28, 2019**” and replacing it with “**August 31, 2019.**”

1.2 Extension of Term. Section 10.01 of the MOMS Agreement is amended and restated in its entirety as follows: “The term of this Agreement shall commence March 3, 1999, and shall terminate on August 31, 2019 at 11:59 p.m., unless sooner terminated in accordance with this agreement.”

1.3 No additional changes. Except as expressly modified in this Fourth Amendment, the provisions of the MOMS Agreement are and shall remain in full force and effect and are hereby ratified and confirmed by the parties.
