The RiNo Denver General Improvement District (GID) was established in 2015 via Ordinance No. 0309, Series of 2015 (Creation Ordinance).

This ordinance seeks to amend the Creation Ordinance to change the number of appointed District Advisory Board (DAB) members for the GID from seven to nine, change the term expirations for DAB members from two consecutive three-year terms to two three-year terms with three additional consecutive one-year terms, and confirms the current DAB member initial term expirations to the following schedule:
