5 **To set a public hearing before City Council on July 8, 2024 for the formation and**  
6 **establishment of the Ballpark Denver General Improvement District and**

16 of the Petition and proposed creation ordinance and the Work Plan and Budget for the proposed  
17 Ballpark Denver General Improvement District;

18 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
19 **DENVER:**

20 **Section 1.** The Denver City Council hereby sets the hearing for 5:30 p.m., or as soon as  
21 possible thereafter, on July 8, 2024, at 1437 Bannock Street, Room 451, Denver, Colorado, on  
22 considering the approval of the Petition in accordance with a proposed creation ordinance and the  
23 Work Plan and Budget for the proposed Ballpark Denver General Improvement District.
