**A BILL**

For an ordinance amending article II of chapter 2 requiring elected officers to adopt and maintain a policy prohibiting themselves and their appointees from engaging in discrimination and harassment.

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** That article II of chapter 2 be amended by adding the language underlined to read as follows:

**Sec. 2-17. –Antidiscrimination and harassment policy requirements of elected officers.**

All elected officers, including city council, the mayor, the auditor, and the clerk and recorder, shall adopt and maintain a policy that strictly prohibits themselves and their appointees from engaging in any behavior constituting discrimination, harassment, and/or retaliation in the scope of employment.

The policy must set forth processes for:

- (a) Reporting complaints against elected officials and appointees to an appropriate third-party;
- (b) Prompt, thorough and impartial investigation of credible complaints;
- (c) Ensuring confidentiality in the process to the extent permissible;
- (d) Prohibiting retaliation for making complaints, and/or attesting, assisting or participating in the process; and,
- (e) Resolution of alleged violations.

None of the requirements set forth in this ordinance should be construed to conflict with other local, state, or federal laws.

**Secs. 2-17—2-30. - Reserved.**

**Section 2.** This ordinance is effective July 1, 2021.
