This ordinance request seeks to transfer and appropriate \$2,698,888.50 from Fund 15828 into Fund 36050 to provide funding in support of the acquisition of 1430 14th Street. The City and County of Denver has a signed Letter of Understanding from the seller, Union Pacific Railroad Company, for \$5,284,125.

DPR's \$2,698,888.50 contribution towards the acquisition is for the portion of the property that is currently used for the Downtown Playground, with the remaining \$2,585,236.50 coming from DOF's 2025 CIP.
