SUBJECT: Petition of Protest - Council Bill #21-0810, Series 2021

OVERVIEW OF STAFF REVIEW PROCESS TO IMPLEMENT REVIEW CONSISTENT WITH DIVISION 12.4.10.11 OF THE CODE.

Step 1: Create 200-foot buffer map - Created by CPD and attached

• The 200-foot buffer includes 250 properties, 238 of which are in the Candlewyck Condominiums, located northeast of the proposed rezoning in the parcel labeled 7877 on the attached map.

Step 2: Confirm that all addresses signed are in the buffer

 All signatures received were from the owners of Candlewyck Condominiums, per the cover letter attached to the protest petition. Each condominium was allocated a partial credit area of 157 square feet based on the area of land within the buffer, divided by the number of owners.

Step 3: Confirm that all signatures are valid and accurately represent ownership

Candlewyck Condominiums submitted 82 signatures.

Step 4: Calculate valid signatures to assess percentage

 All 82 signatures were considered valid and representative of a single property for the purposes of assessing the percentage.

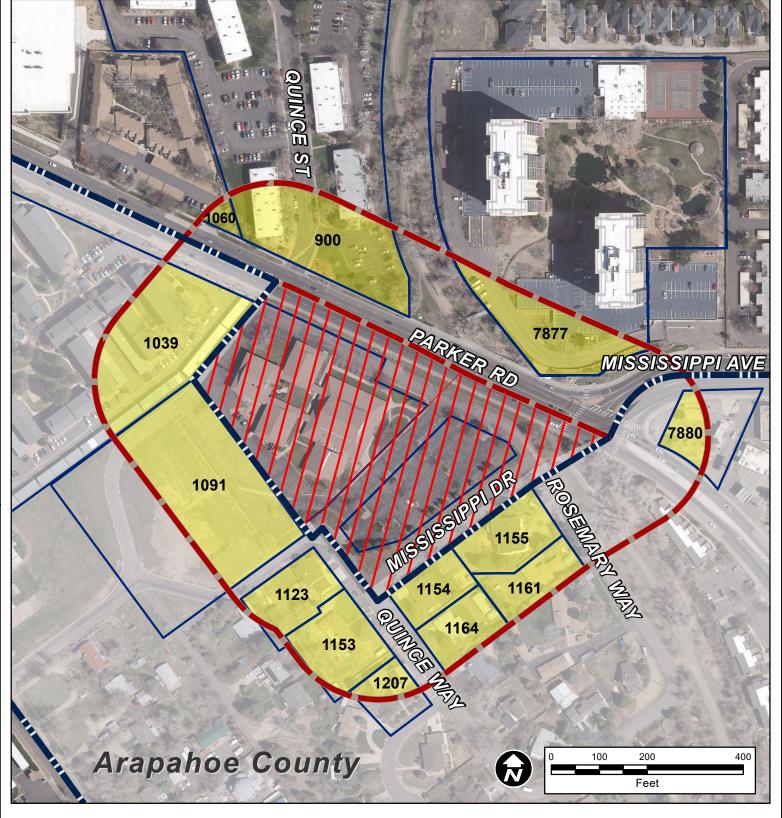

Full or Partial Parcels Within 200' of Proposed Amendment Signatures of the owners of 20 percent or more of the total land area from the perimeter of the area proposed for change to a distance of 200 feet outside is required.

Total area of 200' distance from the perimeter of the amendment = 591,043 Sq Ft

20% = 118,209 Sq Ft Needed

Thank you for giving us the opportunity to file a petition concerning the above. A few things you might want to consider are:

238 units minus 38 renters = 200 units allowed to vote

Our bylaws do not allow us to go door-to-door asking owners to sign petitions. It's a challenge to reach many owners due to many move-ns, move-outs and recent total change of our staff

Traffic at our T-intersection is the primary reason we want the zoning to remain at 1.

Some lower-level owners are unhappy about losing some of their western views. It will probably have a negative impact of the worth of their homes.

80247 is a relatively high crime area. The additional 240 units may have a negative effect on crime. Many owners are senior citizens. They will be further challenged by the increase in traffic and the ability to make a left turn on E. Mississippi.

The exit from the new apartments to S. Parker (turning south-right) will necessitate a u-turn on Parker or turning into a smaller street through a residential neighborhood.

However you vote, it would be great to have some bushes or small trees planted on the nearby median strips on Parker and Leetsdale.

Please consider the above when you cast your vote.
