A BILL

For an ordinance to appropriate funds from the Capital Improvement and Capital Maintenance Fund.

WHEREAS, funds are needed to complete the build out of the new Safety Fleet Service Center located at 2100 31st Street to accommodate the Denver Police Department fleet operations and the Technology Services Electronic Engineering Bureau; and

WHEREAS, the additional funding addresses changed building code requirements, site improvements, fiber optic utility extension and increased labor and materials cost due to market escalation;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Expenditures are hereby authorized from the Capital Improvement and Capital Maintenance Fund, Accounting No. 31000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
