A BILL

For an ordinance making an appropriation in and a rescission from General Fund Contingency and making an appropriation in the General Fund budget for the City Attorney's Office.

WHEREAS, the City Attorney's Office (CAO) has entered a partnership with the U.S.

Attorney's Office (USAO) to address violent crime in Denver; and

WHEREAS, as part of the said partnership, four Associate Assistant City Attorneys will as Special Assistant United States Attorneys (SAUSA) and work with and under supervision AO to deal specifically with the surge of gun crime in Denver and to prosecute cases ng felons in possession of a firearm under 18 USC § 922; and

WHEREAS, the City wishes to increase the CAO 2022 General Fund appropriation;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
