

### Overview of Current Contracts

- General Services currently manages three citywide security personnel contracts, excluding Denver International Airport.
- All contract terms are set to expire on Dec. 31, 2024.

#### **Security Services USA, Inc.**

- \$43M capacity (Current Contract Value)
- Citywide security services
- Covers programmed services (24/7 shelters)
- Contract includes two one-year optional year renewals



#### **Denver Metro Protective Services**

- \$1M capacity (Current Contract Value)
- On-call security services
- No term extensions



#### **Advanced Professional Security Services**


- \$1M capacity (Current Contract Value)
- On-call security services
- No term extensions



These contracts provide citywide security services at 30-plus city facilities/locations excluding Denver International Airport.

Locations include municipal buildings and 24/7 shelters, both programmed and emergency.

### What is provided?

Unarmed (24/7 shelters) and armed security (municipal facilities) personnel services

Customer service/wayfinding

Screening at public entrances (X-ray, magnetometers, wands)

Interior/exterior facility patrols (report damages, maintenance issues)

Respond to alarms and report fire safety violations, FIREWATCH patrols

Security monitoring and Security Operations Center staffing City employee escorts

Emergency/non-emergency evacuation assistance

Lockdown/secure assistance

- Term: 1/1/22-12/31/24 plus two one-year optional renewals

- **Dedicated account positions:** 
  - District manager
  - Two account managers
  - Field supervisor
  - Trainer
  - Firearms instructor
  - EDI specialist
  - Scheduler
  - o Payroll
- Unarmed do not carry firearms or restraints (handcuffs, zip ties). Unarmed do not carry lessthan-lethal measures (including pepper spray, tasers, batons) through observe and report action.

- **Armed** assignments are determined through needs assessment. At this time, armed guards are only assigned to citywide municipal facilities.
- **Quarterly evaluation** of Securitas performance is conducted by the chief security officer and customer agencies.
- **Coordination and engagement meetings** between City, Securitas and The Salvation Army's leadership.
- Minimum required training is 40 hours prior to post assignment, 16 hours of orientation training and 24 hours of instruction-specific (e.g. EDI, Deescalation, implicit bias, medical assistance).

### **Salvation Army and Securitas** operational meetings

 Manager/supervisor regularly communicate above mission, collaboration, standard operations, critical incidents, team accountability, information sharing, process improvement

### **Shift change meetings**

 Staff-to-staff handoff to relay key information from shift to shift (active situations, concerns, work done to address items, proposed work to continue efforts, situational awareness and coordination with Salvation Army)

#### **Critical incident reporting and** communication tree

 Structured, consistent communication pathway for city, provider, and contractor leadership to share information during a critical incident



### New Emergency **On-Call Contracts**

### What is provided?

Emergency on-call security services 24/7/365

Emergency service requests outside normal programmed services

Limited duration service engagements (e.g., cold weather sheltering, newcomer surge)

### Three-tiered response time:

- Reporting on-site within 24 or less hours notification
- Reporting on-site within at least 72 hours notification
- Reporting on-site with more than 72 hours notification



# Strategic Enhancements for Future Security Solicitations

- Restructure RFP to improve clarity, accountability, performance data-driven outcomes, and transparency (reporting, training, administrative requirements, site supervision needs, etc.).
- Revisit training requirements and cadence with agency partners to ensure relevancy.
- Investigate master security officer (MSO)
   positions. Provide increased/elevated
   knowledge, mentorship, guidance, and
   support.

- Encourage subcontracts with diverse (MWBEs) and specialized security service providers to address city's varied needs (municipal, housing, sheltering).
- Increase dedicated trainers on city account: one general, one firearm instructor, and one new specialized trainer for trauma-informed care with mental health focus.
- Encourage retention, reward, and recognition programs and benefits.

### Additional Notes on Current Securitas Contact

GENRL-202475863-00 (GENRL-202161226-03)

- Services vary by site and are determined in consultation between the Denver Security Office and the requesting agency.
- Guard counts:
  - o 2022: ~175 guards
  - o 2024: ~250 guards, including 18 armed
- Armed assignments are determined through a needs assessment; considerations for lone posts, posts outside the downtown core, location's cash function, critical function without Safety presence.
- 24/7 shelter sites are unarmed.

- Minimum required training is 40 hours; includes:
  - Respect/Empathy/Implicit Bias/Trauma-Informed Care
  - o Informed, Compassionate, and Positive Interactions with Persons Experiencing Homelessness
  - o Equity, Diversity, and Inclusion
  - Challenging and De-Escalation Techniques
  - Emergency Medical Assistance and First Aid
- Experience providing service to the city during the COVID-19 pandemic at the Coliseum and multiple hotels activated for respite care.
- 14% goal; 12% achieved to date through subcontractor engagement.
- Existing CBA between Securitas and the SEIU Local 105 (term 1/1/2022-12/31/2024).

- Dedicated Securitas supervisor based on no proximity to other city supervised sites
