A BILL

For an ordinance approving and providing for the execution of a proposed contract between the City and County of Denver and the State of Colorado concerning the "Community Corrections FY17-18" program and the funding therefor.

WHEREAS, the State of Colorado, Department of Public Safety, Division of Criminal Justice, has notified the City of funding allocations for Fiscal Year 2017-2018 for Community Corrections services under a contractual agreement with the City, a copy of which is duly filed with the Clerk and Recorder, Filing No. 14-0157;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Allocation Letter, CMS No. 68057, between the State of Colorado and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 17-0279, be and hereby are approved in all respects.

Section 2. The payments made by the State of Colorado to the City pursuant to and under the Contracts shall be deposited into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Community Corrections FY17-18" program, Accounting No. 12302-3501101-X3005, is as follows, to be expended by the Executive Director of Safety:

Authorization for expenditure of said funds following execution of said contracts will cover the period from July 1, 2017 to June 30, 2018.
