### Staff Report and Recommendation

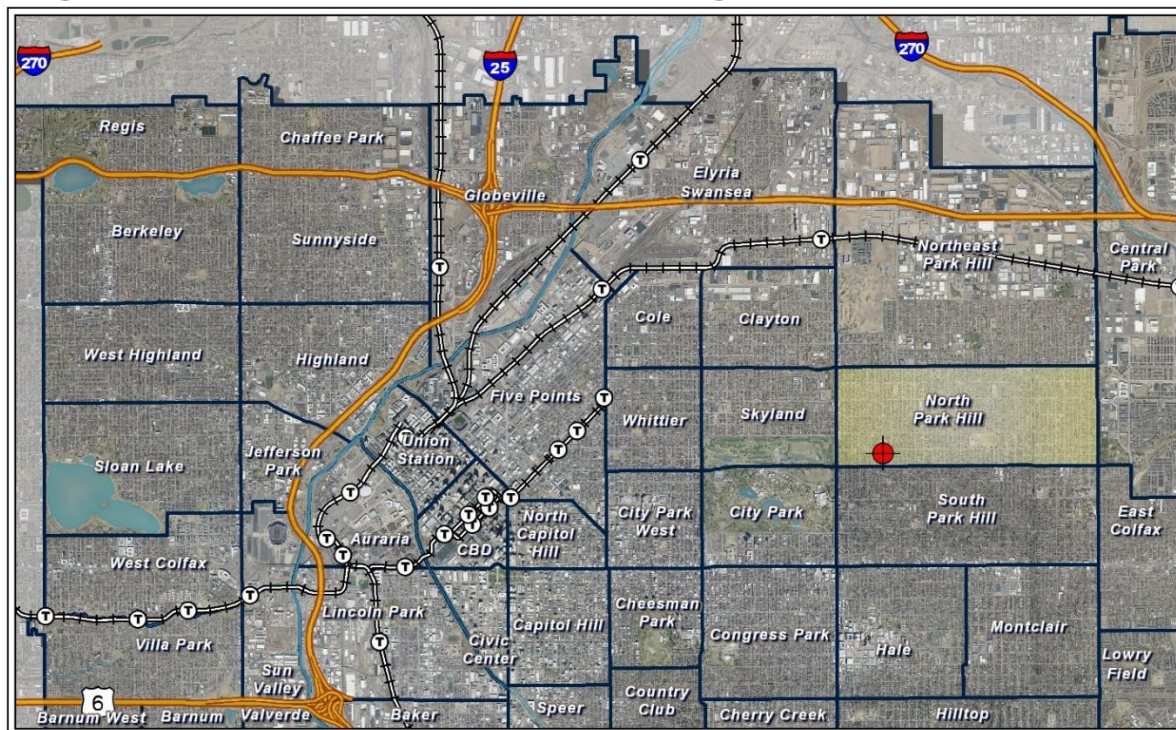
Based on the criteria for review in the Denver Zoning Code, Staff recommends that the Land Use, Transportation, and Infrastructure Committee move Application #2023i-00137 forward for consideration by the full City Council.

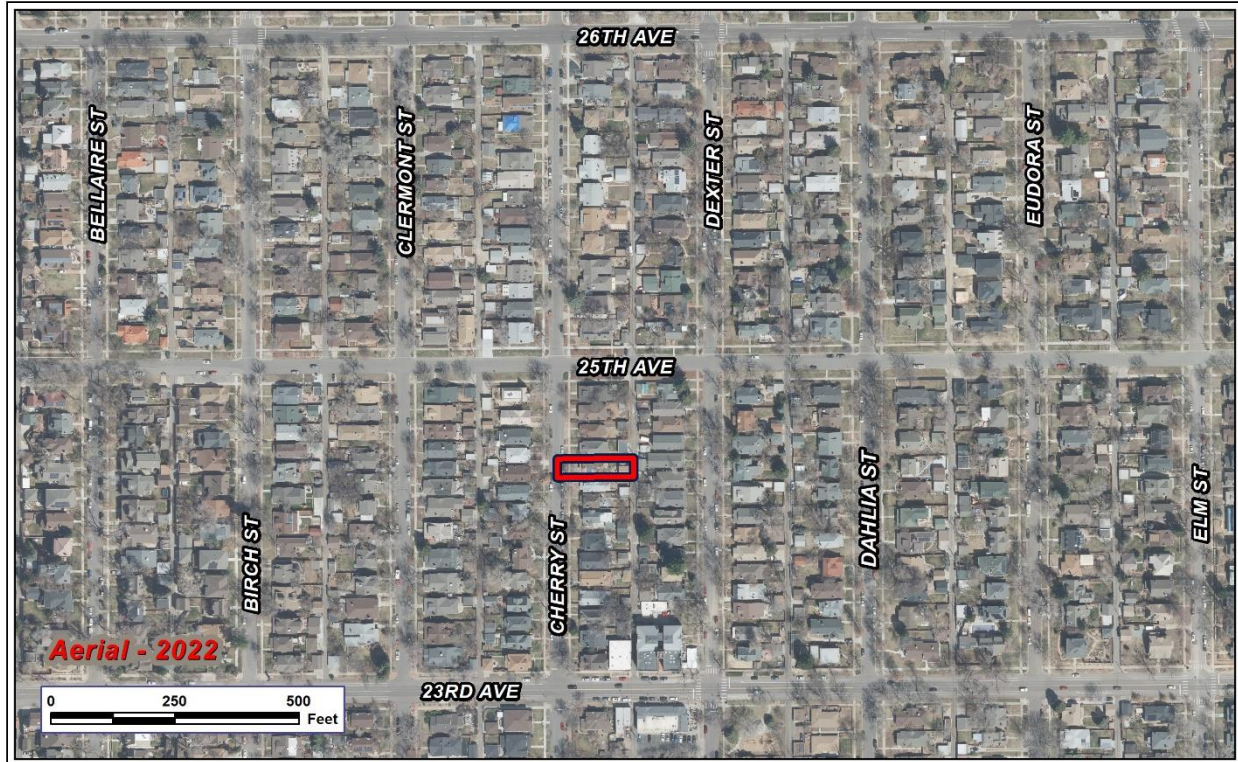
### Summary of Rezoning Request

- The property at 2360 North Cherry Street was built circa 1911. The property owners are proposing to rezone their property to allow for an accessory dwelling unit (ADU).
- The proposed U-SU-C1, Urbane, Single-Units, C1 (5,500 square feet minimum zone lot size allowing accessory dwelling units (ADUs)), zone district is intended for use in the Urban Neighborhood Context which is characterized by single-unit and two-unit uses. Single-unit residential uses are typically located along local and residential arterial streets and structures with the Urban House building form. The maximum height of the Urban House building form is 30 to 35 feet for the front 65% of the zone lot and 17 to 19 feet in the rear 35% of the zone lot. The Detached Accessory Dwelling Unit building form can be a maximum height of 24 feet. Further details of the requested zone district can be found in the proposed zone district section of the staff report (below) and in Article 5 of the Denver Zoning Code (DZC).
- Based on Denver Zoning Code Sec. 12.10.3, Use and Development of Nonconforming Zone Lots, allows construction of primary dwelling units and detached accessory dwelling units on zone lots that do not meet minimum lot size standards.





## Existing Context



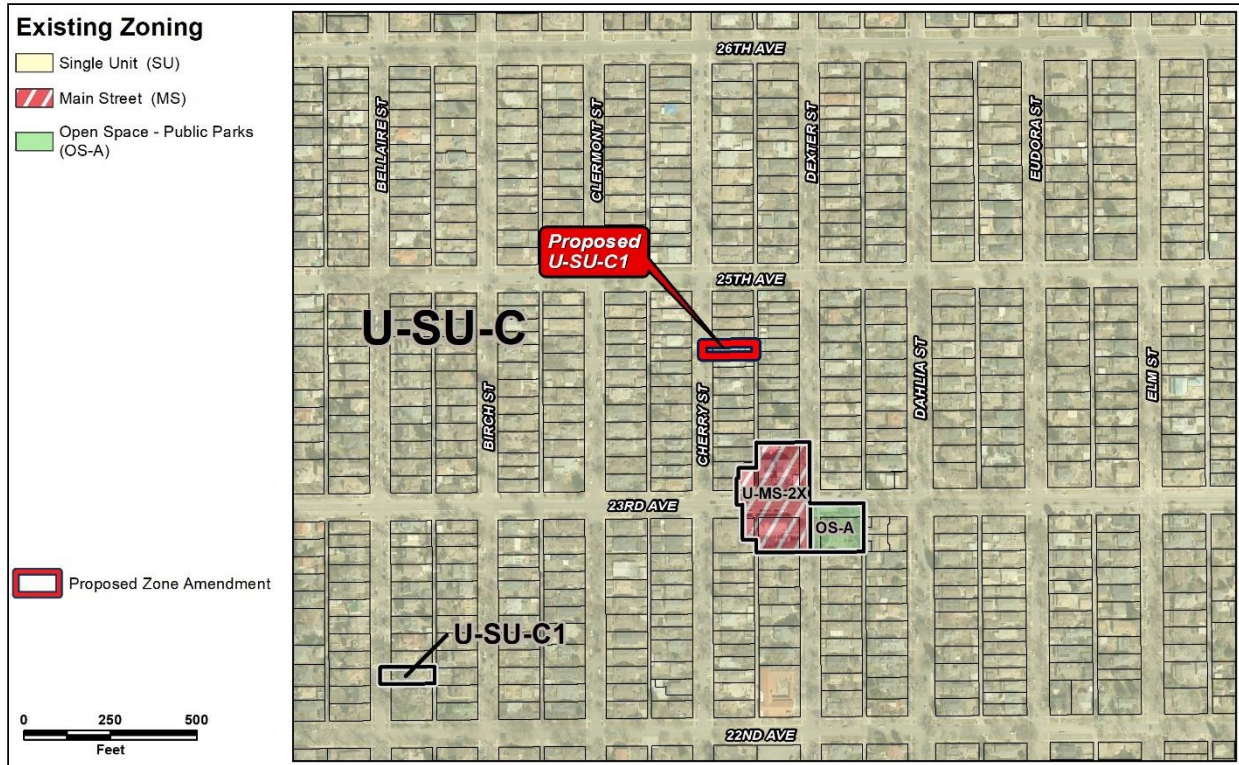
The subject property is in the North Park Hill statistical neighborhood, which is characterized mostly by single-unit residential uses, with interspersed two-unit and multi-unit residential uses, and nodes of neighborhood serving commercial/retail. Generally, there is a pattern of rectangular blocks in a street grid pattern with alley access. The subject property is between East 25<sup>th</sup> and East 23<sup>rd</sup> Avenues. It is less than a block from a RTD bus stop on East 23<sup>rd</sup> Avenue for Route 20 traveling east/west. It is also less than a half-mile from City Park.

## 1. Existing Zoning



The U-SU-C zone district is a single-unit residential district with a minimum zone lot size of 5,500 square feet and allows the Urban House primary building form. The maximum allowed height is 2.5 stories or 30 to 35 feet in the front 65% of the zone lot, 1 story and 17 feet to 19 feet in the rear 35% of the zone lot. It allows two accessory structure forms: Detached Garage and Other Detached Accessory Structure. The maximum height is 17 feet for detached garages and 15 feet for other detached accessory structures. The intent of the district is to promote and protect residential neighborhoods within the character of the Urban Neighborhood Context.

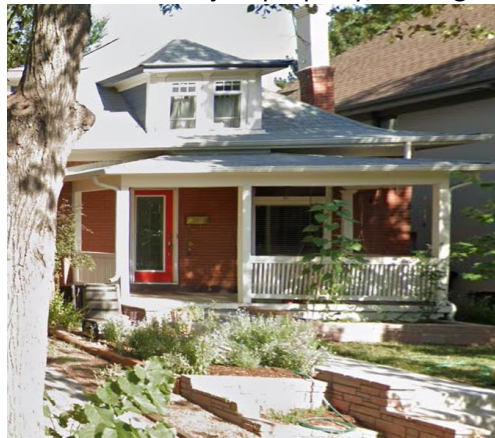

### **Proposed Zoning**

U-SU-C1 is a single-unit zone district with a minimum zone lot size of 5,500 square feet, allowing only the Urban House primary building form. A variety of residential and civic uses are permitted as primary uses in the U-SU-C1 district. The district allows the Detached Accessory Dwelling Unit (DADU), Detached Garage, and Other Detached Accessory Structured as detached accessory building forms. The Detached Accessory Dwelling Unit building form has a maximum height of 2 stories or 24 feet. A bulk plane that raises 10 feet vertically from the side interior or side street zone lot line, then slopes 45 degrees applies to the DADU building form. This form also allows an exemption from the 37.5% building coverage standard, allowing 50% of the building footprint of the DADU to be excluded up to a maximum of 500 square feet. The subject site has a lot size of 4,460 square feet, allowing a maximum building footprint of 864 square feet for the DADU.

The primary building forms and relevant standards of the detached accessory dwelling unit accessory building forms allowed in the existing zone district and the proposed zone district are summarized below.

## Summary of City Agency Referral Comments

As part of the DZC review process, the rezoning application is referred to potentially affected city agencies and departments for comment. A summary of agency referral responses follows:

**Assessor:** Approved – No Response.

**Asset Management:** Approved – No Comments.

**Denver Public Schools:** Approved – No Response.

**Development Services - Fire:** Approved – No Comments.

**Development Services – Project Coordination:** Approve Rezoning Only - Will require additional information at Site Plan Review

- 1) The property will need to obtain building permits and zoning use and construction permits before construction can commence.
- 2) Plan reviews will be conducted by Residential Review Team.
- 3) All new construction will need to conform with determined building form standards and DZC requirements.
- 4) Per the rezoning application and City GIS, the lot size of the current zone lot appears to be 4,460 s.f. and about 37.5' wide. However, the available building forms for both Urban House and Tandem house in the U-SU-C and U-SU-C1 require a minimum zone lot area of 5,500 s.f. and 50' wide.
- 5) Thus, the current zone lot would be considered a non-conforming zone lot as it does not meet the minimum area and width requirements for any of the available building forms in the current zone district. Rezoning it to the U-SU-C1 would also create the zone lot as non-conforming in the new district.
- 6) DZC allows the use and development on existing, legally established nonconforming zone lots per 12.10.3.4. and 12.10.
- 7) DZC 12.10.3.4. indicates that the existing structure would need to be designated as Urban House.
  - DZC 12.10.3.4.B. Applicable Detached Accessory Building Form(s) for Development on Nonconforming Zone Lots Development of a detached accessory structure, including alterations to an existing detached accessory structure, on a nonconforming zone lot shall comply with the standards for a detached accessory building form permitted in the zone district.
  - DZC 12.10.3.4.C. Application of Building Form Standards
    1. Development on a nonconforming zone lot under the selected building form shall comply with all applicable building form standards, except that compliance with a building form's minimum zone lot size or width standards is not required for new development.
    2. Development under the selected building form shall comply with the Setback and Building Coverage by Zone Lot Width form standards that align with the nonconforming zone lot's width.
- 8) Given the nuances of the restrictions on development on a non-conforming zone lot, it is recommended to meet with the Residential Plan review team to discuss the intended development plans prior to the rezoning moving forward to determine feasibility of desired outcomes. The reduced lot size and width, along with requirements to construct within current building form standards, may limit development potential. The Residential Review team may be contacted via 720-865-2710 or ResidentialPermits@denvergov.org. It would be recommended to preface the request for the pre-

application meeting with the statement that a rezoning application is in the review process and referral agencies recommended the pre-application meeting to discuss development feasibility prior to the rezoning application continuing.

8) Rezoning and development applications are pursued at the Owner's risk.

**Development Services - Transportation:** Approved – No Response.

**Development Services – Wastewater:** Approved – See No Response.

**Parks and Recreation:** Approved – No Comments.

**Public Health and Environment:** Approve Rezoning Only - Will require additional information at Site Plan Review.

Denver Department of Public Health & Environment - Division of Environmental Quality (EQ) does not guarantee approval of any proposed development project at this site by providing a response to this Official Map Amendment Referral Agency Review Request. Future development is subject to existing land use controls and other environmental requirements in accordance with applicable local, state, and federal environmental regulations and statutes. EQ recommends the Property Owner conduct an environmental site assessment to determine the potential presence, nature, and extent of possible contamination on the site and to identify specific cleanup needs associated with future development. EQ may have additional information about localized potential environmental concerns at the site. However, providing such information about a specific site is beyond the scope of these zoning application comments.

## **1. Consistency with Adopted Plans**

The following adopted plans apply to this application:

- *Denver Comprehensive Plan 2040 (2019)*
- *Blueprint Denver (2019)*
- *Park Hill Neighborhood Plan (1991)*

### **Denver Comprehensive Plan 2040**

The proposed rezoning is consistent with many of the adopted *Denver Comprehensive Plan 2040* strategies, including:

- Equitable, Affordable and Inclusive Goal 2, Strategy A – Create a greater mix of housing options in every neighborhood for all individuals and families (p. 28).

U-SU-C1 allows for an additional dwelling unit that is accessory to the primary single-unit dwelling use and introduces a new housing type to a largely single-family neighborhood. Accessory dwelling units can provide housing for individuals or families with different incomes, ages, and needs compatible with the single-unit homes that are most common in the North Park Hill.

- Strong and Authentic Neighborhoods Goal 1, Strategy B.: "Ensure neighborhoods offer a mix of housing types and services for a diverse population" (p. 34).

The proposed rezoning would allow infill development appropriate for the surrounding neighborhood that broadens the range of housing types available.

- Environmentally Resilient Goal 8, Strategy A – Promote infill development where infrastructure and services are already in place (p. 54).

The proposed map amendment will allow an additional housing unit on the site of an existing home where infrastructure and services such as water, stormwater, and streets already exist. This allows

Denver to grow responsibly and promotes land conservation. Because it implements the strategies cited above, the rezoning is consistent with *Comprehensive Plan 2040*.

### **Blueprint Denver**

*Blueprint Denver* was adopted in 2019 as a supplement to *Comprehensive Plan 2040* and establishes an integrated framework for the city's land use and transportation decisions. *Blueprint Denver* identifies the subject properties as part of a Low Residential place within the Urban Neighborhood Context and provides guidance on the future growth strategy for the city.

### **Blueprint Denver Future Neighborhood Context**



In *Blueprint Denver*, future neighborhood contexts are used to help understand differences between land use, built form, and mobility at a high scale, between neighborhoods. The subject site is shown on the context map as Urban neighborhood context, the description of which is used to guide appropriate zone districts (p. 66). The Urban neighborhood context is described as containing “small multi-unit residential and low-intensity mixed-use buildings typically embedded in single-unit and two-unit residential areas” with grid block patterns and alley access (p. 222). U-SU-C1 is a zone district within the Urban neighborhood context and is “intended to promote and protect residential neighborhoods within the character of the Urban Neighborhood Context” and “the building form standards, design standards and uses work together to promote desirable residential areas” (DZC 5.2.2.1). U-SU-C1 is consistent with

the *Blueprint Denver* future Urban neighborhood context because it will promote the residential character by allowing single-unit residential uses with a low-scale accessory dwelling unit that will be compatible with the existing residential area.

### **Blueprint Denver Future Place Type**



The subject site is designated within a Low Residential future place on the *Blueprint Denver* Future Place map. This place type is “predominately single- and two-unit uses on smaller lots. Accessory dwelling units and duplexes are appropriate and can be thoughtfully integrated where compatible,” and “building heights are generally up to 2.5 stories in height” (p. 230). U-SU-C1 is a single-unit residential district that allows for an additional dwelling unit accessory to a primary single-unit residential use, which is consistent with the Low Residential future place description. It allows the Urban House building form, which has a maximum height of 2.5 stories, also consistent with the future places map.

### **Blueprint Denver Street Types**

In *Blueprint Denver*, street types work together with the future place to evaluate the appropriateness of the intensity of the adjacent development (p. 67). *Blueprint Denver* classifies North Cherry Street as a Local or Undesignated Street. “Local streets can vary in their land uses and are found in all neighborhood contexts. They are most often characterized by residential uses. Local streets provide the lowest degree of through travel but the highest degree of property access.” (p. 161) The proposed U-SU-C1 zone district is consistent with this description because it allows for residential and some civic uses.



### **Blueprint Denver Growth Strategy**



*Blueprint Denver's* growth strategy map is a version of the future places map, showing the aspiration for distributing future growth in Denver (p. 51). The subject property is included as "All other areas of the city" growth area. These areas anticipate experiencing around 20% of new housing growth and 10% of new employment growth by 2040 (p. 51). These growth areas are "mostly residential areas with embedded local centers and corridors, take a smaller amount of growth intended to strengthen the existing character of our neighborhoods" (p. 49). The proposed map amendment to U-SU-C1 will allow for low-intensity growth to the number of households in this area by allowing the development of a detached accessory dwelling unit on each site and is therefore consistent with the growth strategy.

### **Blueprint Denver Strategies**

*Blueprint Denver* provides recommendations related to rezoning to allow for ADUs.

- Housing Policy 4 Strategy E: "A citywide approach to enable ADUs is preferred. Until a holistic approach is in place, individual rezonings to enable ADUs in all residential areas, specifically where proximate to transit, are appropriate. Unless there is a neighborhood plan supporting ADUs, rezonings should be small in area in order to minimize impacts to the surrounding residential area." (p. 84).
- Housing Policy 5: "Remove barriers to constructing accessory dwelling units and create context-sensitive form standards." (p. 84).

This rezoning to an ADU zone district will have minimal impacts on the character of the surrounding neighborhood and is consistent with *Blueprint Denver* recommendations. In addition, the rezoning of the subject property will remove the prohibition on the construction of an accessory dwelling unit.

**Small Area Plan: Park Hill Neighborhood Plan (1991)**

This neighborhood plan does not specifically call out accessory dwelling units but has applicable recommendations that support this rezoning application.

- Land Use LZ-3 – Create and maintain a mix of housing types and sizes that are attractive and affordable to a diversity of ages, incomes, household types, sizes, cultural and ethnic backgrounds. (p. 33)

The proposed zone district allows for compatible, low-density residential development with its allowances for the Urban House primary building form and detached ADU building form.

## **2. Uniformity of District Regulations and Restrictions**

The proposed rezoning to U-SU-C1 will result in the uniform application of zone district building form, use, and design regulations.

## **3. Public Health, Safety and General Welfare**

The proposed official map amendment furthers the public health, safety, and general welfare of the city through implementation of the city's adopted land use plan which recommends "the expansion of accessory dwelling units throughout all residential areas" (p. 84). The proposed rezoning would also provide the benefit of an additional housing unit that is compatibly integrated into the surrounding neighborhood. The building form standards and allowed uses of the proposed zone district promote compatibility with the building forms and uses allowed in the surrounding area.

## **4. Justifying Circumstance**

The application identifies the adoption of *Blueprint Denver* as the Justifying Circumstance under DZC Section 12.4.10.8.A.4, "Since the date of the approval of the existing Zone District, there has been a change to such as degree that the proposed rezoning is in the public interest. Such a change may include: Changed or changing conditions in a particular area, or in the city generally; or a city adopted plan; or that the city adopted the Denver Zoning Code and the property retained Former Chapter 59 zoning."

As discussed above, *Blueprint Denver* specifically recommends the city diversify housing choice through the expansion of accessory dwelling units throughout all residential areas. The plan was adopted after the date of approval of the existing zone district. Therefore, this is an appropriate justifying circumstance for the proposed rezoning.

## **5. Consistency with Neighborhood Context Description, Zone District Purpose and Intent Statements**

The requested U-SU-C1 zone district is within the Urban Neighborhood Context. The neighborhood context is “primarily characterized by single-unit and two-unit residential uses” and “single-unit residential structures are typically the Urban House building form” (DZC, Division 5.1.1). These areas consist of “regular pattern of block shapes” and “a consistent presence of alleys” (DZC, Division 5.1.2). The North Park Hill neighborhood consists of mostly single and two-unit residential uses in rectangular blocks with alley access. The proposed rezoning to U-SU-C1 is consistent with the neighborhood context description.

The general purpose of residential zone districts in this context is to promote and protect residential neighborhoods within the character of the Urban Neighborhood Context (DZC Section 5.2.2.1). The building form standards, design standards, and uses work together to promote desirable residential areas. Common residential characteristics are recognized but variation is accommodated. The proposed U-SU-C1 district is consistent with the context description and the zone district general purpose because it will help preserve the existing single-unit use, form, and streetscape of the immediate area while allowing a small-scale ADU in the rear yard.

The specific intent of the U-SU-C1 zone district is a single unit district allowing urban houses with a minimum zone lot area of 5,500 square feet and detached accessory dwelling units. Blocks typically have a pattern of 50-foot-wide lots. Setbacks and lot coverage standards accommodate front and side yards similar to U-SU-C but allowing a detached accessory dwelling unit building form in the rear yard.” (DZC 5.2.2.2.E.). Based on Denver Zoning Code Sec. 12.10.3, Use and Development of Nonconforming Zone Lots, allows construction of primary dwelling units and detached accessory dwelling units on zone lots that do not meet minimum lot size standards. Therefore, rezoning this site to U-SU-C1 is consistent with the neighborhood context description.
