

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this as of the date set forth on the signature page below (the “Amendment Effective Date”) by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”), Party of the First Part and **AECOM TECHNICAL SERVICES, INC.**, a corporation organized under the laws of California and authorized to do business in Colorado (the “Consultant”), Party of the Second Part. Each party may individually be referred to as a “Party” or collectively as the “Parties”.

WITNESSETH:

WHEREAS, the City owns, operates and maintains Denver International Airport, (hereinafter referred to as “DEN” or the “Airport”); and

WHEREAS, on June 15, 2018 the City and Consultant entered into a Contract for consulting services to assist DEN with Professional Engineering Services to perform formal and incidental design, software support, project management, computer aided drafting, technical documentation, assessments, and other engineering assignments for projects related to electronics and technology systems at DEN (the “Existing Agreement”), and;

WHEREAS, the parties desire to amend the Existing Agreement to extend the Term of the Existing Agreement;

WHEREAS, the City is using a new contract management software system, and as a result, the contract number for this Agreement is being changed from 201736128 to 202056317;

NOW, THEREFORE, the parties hereto agree as follows:

1. Section 3 of the Existing Agreement, entitled “Term” is hereby amended and restated to read as follows:

“3. TERM: The Term of this Agreement shall commence June 15, 2018, and shall terminate on June 14, 2023, unless sooner terminated in accordance with the provisions of this Agreement. No extension of the Term shall increase the Maximum Contract Liability stated herein; such amount may be changed only by a duly executed written amendment to this Agreement.”

2. **Exhibit C, “Rates”** of the Existing Agreement is hereby deleted and replaced with the attached revised **Exhibit C, “Rates”**. Such attachment is incorporated into the Existing Agreement by this reference.

3. Except as otherwise provided herein, all of the terms, provisions, and conditions of the Existing Agreement shall remain in full force and effect as though set out in full here, and are hereby ratified and reaffirmed.

4. This First Amendment to Agreement shall not become effective or binding on the City until it is approved by the City Council if so required by the City’s Charter, and it is fully executed by all signatories of the City and County of Denver.


