A BILL

For an ordinance assessing the annual costs of the continuing care, operation, repair, maintenance, and replacement of the St. Luke's Pedestrian Mall Local Maintenance District upon the real property, exclusive of improvements thereon, benefited.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Upon consideration of the recommendation of the Executive Director of the Department of Transportation and Infrastructure that an ordinance be enacted for the purpose of assessing the annual costs of the continuing care, operation, repair, maintenance, and replacement of the St. Luke's Pedestrian Mall Local Maintenance District ("St. Luke's Pedestrian Mall"), for the upcoming year, upon the real property, exclusive of improvements thereon, benefited, the Council finds, as follows:

(a) A local maintenance district providing for the continuing care, operation, repair, maintenance and replacement of the St. Luke's Pedestrian Mall, was created by Ordinance No. 878, Series of 2000;

(b) The annual cost of the continuing care, operation, repair, maintenance and replacement of the St. Luke's Pedestrian Mall is \$293,689.48, which amount the Executive Director of the Department of Transportation and Infrastructure has the authority to expend for the purposes stated herein;

(c) The Executive Director of the Department of Transportation and Infrastructure has complied with all provisions of law relating to the publishing of notice to the owners of real properties to be assessed and to all persons interested generally, and the Council sitting as a Board of Equalization has heard and determined all written complaints and objections, if any, filed with the Executive Director of the Department of Transportation and Infrastructure;

(d) The real property within the St. Luke's Pedestrian Mall will be benefited in an amount equal to or in excess of the amount to be assessed against said property because of the continuing care, operation, repair, maintenance and replacement of said St. Luke's Pedestrian Mall.

1 **Section 2.** The annual cost of the continuing care, operation, repair, maintenance, and
 2 replacement of the St. Luke's Pedestrian Mall to be assessed against the real properties, exclusive
 3 of improvements thereon, benefited are hereby approved.

4 **Section 3.** The annual costs of the continuing care, operation, repair, maintenance, and
 5 replacement of the St. Luke's Pedestrian Mall in the amount of \$293,689.48 apportioned and
 6 assessed among the real properties benefited, exclusive of improvements thereon, as follows with
 7 a parcel's schedule number as the property identifier:

11 **Section 4.** The assessments made pursuant hereto shall be a lien in the several amounts
 12 assessed against each lot or tract of land set forth in Section 3 herein, and such lien shall have the
 13 priority of the lien for local public improvement districts.

14 **Section 5.** Without demand, said assessments as set forth in Section 3 herein, shall be due
 15 and payable on the first day of January of the year next following the year in which this assessing
 16 ordinance became effective, and said assessments shall become delinquent if not paid by the last
 17 day of February of the year next following the year in which this assessing ordinance became
 18 effective. A failure to pay said assessments as hereinabove set forth shall become a lien on the
 19 property subject to the assessment, and such lien may be sold by the City as provided by the Charter
 20 and ordinances of the City and County of Denver.

21 **Section 6.** Any unspent revenue and revenue generated through investment shall be
 22 retained and credited to the St. Luke's Pedestrian Mall Local Maintenance District for future long
 23 term or program maintenance of the District.

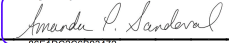
