[16-1266](#) Amends a contract with Mental Health Center of Denver (MHCD) by adding \$448,692 for a total contract in the amount of \$897,384 and extending the term by one year for a new end date of 12-31-17 for citywide housing and wrap around services serving a minimum of 60 female and male clients per year who have high level of co-occurring mental health, substance abuse, and trauma experiences (2016-29249-01).
