CR16-0338 A resolution approving a proposed resolution First Amendment to Contract between the City and County of Denver and Delta Air Lines, Inc. concerning the use and lease at Denver International Airport.

Amends a use and lease agreement with Delta Air Lines, Inc. by adding \$1,562,000, for a new total of \$16,122,000 annually, and extending the term of the contract by 2 years to 12-31-18 in order to continue operating at Denver International Airport (201205588). The last regularly scheduled Council meeting within the 30-day review period is on 6-13-16. The Committee approved filing this resolution by consent on 5-12-16.

CR16-0339 A resolution approving a proposed resolution for an On-Call Technologies Strategic Partners Agreement between the City and County of Denver and Sogeti USA, LLC concerning technology at Denver International Airport.

Approves an on-call technologies contract with Sogeti USA, LLC for \$5 million over three years for professional services on an as-needed basis for staff augmentation,

Adds \$1.5 million to the contract with Sierra-Cedar for a new total of \$7 million to install Workday, the City's new financial and personnel management technology, at Denver International Airport (201523139). Approves a contract with Mile High Montessori Early Learning Centers for full funding in the amount of \$1,682,721 through 6-30-17 to provide direct Head Start services to 269 children (MOEAI 201626987). The last regularly scheduled Council meeting within the 30-day review period is on 6-13-16. The Committee approved filing this resolution by consent on 5-5-16.

CR16-0328 A resolution approving a proposed Agreement between the City and County of Denver and Catholic Charities and Community Services of the Archdiocese of Denver for Head Start Services for Program Year 2016-2017.

Approves a contract with Catholic Charities and Community Services of the Archdiocese of Denver for full funding in the amount of \$1,510,802 through 6-30-17 to provide direct Head Start services to 224 children (MOEAI 201626971). Approves a contract with Clayton Early Learning for full funding in the amount of \$1,424,825 and through 6-30-17 to provide direct Head Start services to 236 children (MOEAI 201626973). CR16-0337 A resolution approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the

Office of National Drug Control Policy concerning the "High Intensity Drug Trafficking area (H.I.D.T.A.) FY16" program and the funding therefor.

Approves a grant agreement with the Office of National Drug Control Policy (ONDCP) for \$908,343 through 12-31-17 to support initiatives designed to implement the strategy proposed by the Executive Board of the Rocky Mountain High Intensity Drug Trafficking Area and administered by the Denver Police Department (CE-61220-04). The last regularly scheduled Council meeting within the 30-day review period is on 6-13-16. The Committee approved filing this resolution by consent on 5-12-16.

CR16-0340 A resolution authorizing expenditures in the Human Services Special Revenue Fund based on a letter of intent from United States of America to award funding for the "Emergency Solutions Grant FY16" program.

Appropriates 50% of a grant award, or \$305,738, through 6-30-17 based on the Letter of Intent provided by the U.S. Department of Housing and Urban Development, for an estimated full award of \$611,476, for the Emergency Solutions Grant which funds emergency services to reduce homelessness.
