CR16-0058 A resolution approving a proposed Fourth Amendment to Contract between the City and County of Denver and B2GNow/Ask Reply, Inc. concerning professional and technical services at Denver International Airport.

Amends a contract with B2GNow/Ask Reply, Inc. to add \$57,750 for a new contract total of \$1,122,362 to add and maintain functionality to the current system to better track payments to subcontractors (CE61401).
