22	Accounting No. 11882 shall be deposited into the Treasury of the City and credited to Special			
23	Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal			
24	Code of the City and County of Denver.			
25	Section 3. Program expenditures are hereby authorize	zed for the "Transportation and Mobility"		
26	Fund, Accounting No. 11882, to be expended by the Ex	xecutive Director of the Department of		
27	Transportation and Infrastructure. Allowable expense	es include program costs to support		
28	transportation and mobility programs, including personnel, services and supplies, capital equipment,			
29	and appropriated transfers to the Capital Improvements and Capital Maintenance Fund for capital			
30	projects. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund.			
31	This Fund is appropriated and non-lapsing.			

1	Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized		
2	and directed to make such book and record entries and to do such other things as may be necessary		
3	to accomplish the purposes of this Ordinance.
