1. Tell us about your expertise in the immigrant or refugee community in Denver

As chair of Community Service for the Asian Pacific American Bar Association, I have spearheaded a number of programs and projects that positively impacted the Asian immigrant and refugee community in Denver in tangible ways. Among other things, I organized elder law days, in which low income Asian immigrants received free legal assistance in executing advance planning documents, which were especially vital during COVID-19, when seniors were the most vulnerable. In the midst of COVID-19, I also established a virtual legal hotline wherein attorneys provided pro bono legal assistance to the Asian refugee and immigrant community. I also developed the Compassion in Colorado project, a companion service which pairs volunteers with Asian seniors who might otherwise be fearful to go out into the community in light of recent hate crimes against the APA community. Volunteers provide companionship by walking with seniors, accompanying them to medical appointments, and running errands. Finally, I have led community-wide efforts with a holiday gift bag drive for low income seniors at the Volunteers of America senior facilities for the past two years, as well as the feed-a-senior drive, which raised money to bring hot meals to our seniors. This year, I also led a lunar new year gift basket drive benefiting refugee families of the Asian Pacific Development Center.

In addition, in my day job as a labor and employment attorney representing mainly plaintiffs, a large percentage of my clients are part of the immigrant and refugee community, and I work hard to ensure that their rights are protected and they are treated fairly in the workplace.

2. Tell us about your expertise in your professional field.

I have practiced law for over 20 years and am licensed as an attorney in Colorado and California. I have practiced commercial litigation as an associate at a national law firm, served as an Assistant United States Attorney where I represented the United States in civil litigation as well as civil fraud matters against large corporations; and represented management as a labor and employment attorney for the Department of the Interior. In January 2020, I opened up my own law practice in order to represent workers and small businesses in Colorado. Please see my resume attached for more information about my work experience.

3. What strengths do you feel you bring to the Commission?

As an attorney, I am able to efficiently review and analyze legal and other esoteric material and distill the information being presented into manageable and understandable terms. I am very connected to the Asian community and stakeholders in particular and am knowledgeable regarding many of the issues facing Asian Americans in Denver today. I am organized and a natural planner who loves to execute ideas to benefit the community.

4. What are the biggest challenges you see facing immigrant and refugee communities in Denver?

There is a language barrier for many immigrants and refugees such that they are unable to understand and access many of the resources that might otherwise be available to them. Additionally, due to lack of financial and other means, they are not

able to obtain many of the benefits they are entitled. They are taken advantage of and do not know where to go to get help and often cannot afford legal and other assistance which they need to climb the economic ladder.

5. What are some of the issues or opportunities in Denver that immigrants & refugees can address together?

We can work on ways to address the language barrier and discuss how we can get more information on financial, educational, and other resources to the immigrant and refugee community. We need to discuss ways to improve access to housing, healthcare and education.

6. How do you engage with a person whose opinions are different than your own?

I deal with this everyday in my profession dealing with opposing counsel and parties whose opinions differ from mine and my clients. I try to put myself in their shoes and understand where they are coming from. I ask questions in order to engage them and understand their point of view, position, and concerns. I ask myself whether this is an issue or opinion that needs to be changed or commented on, and if not, I listen and respect the opinion and I move on. If it's an opinion that I'd like to comment on and perhaps change that person's perspective, I try to do so by asking pointed questions or commenting, but in a positive way that does not embarrass anyone or create hostility (e.g., doing so in private).

7. Describe a project or initiative in your field of expertise that you led or played a significant role in, and what was the result

I took on 5 federal district court cases in 2020 on a pro bono basis where I represented plaintiffs who were unable to afford an attorney but who were discriminated against in the workplace on the basis of a protected classification. One was a recent immigrant to the U.S. who was discriminated against because of her accent. I was proud to have reached settlements for each of these plaintiffs to restore accountability to the workplace and ensure they were compensated for these workplace violations.

8. Describe a project or initiative in your community that you led or played a significant role in, and what was the result.

As mentioned in my answer to Question 1 above, I have led a number of outreach projects over the years. One of the projects I was most proud of was creating a free virtual legal clinic/hotline for people needing legal assistance from an experienced attorney. These are people in our community, many of whom were immigrants and refugees, who could not otherwise afford counsel.
