24	Section 1. A new Fund is hereby established in	the Community Development Special Revenue
25	Fund Series, Accounting No. 16000, a "HOST Perfo	rmance Contracts" Fund, Accounting No. 16814,
26	for the purpose of accounting for the receipt and expenditure of program dollars.	
27	Section 2. Monies received from General Fund transfers, transfers from the current Social	
8.	Impact Program Fund, Accounting No. 11863, and other sources of income for Accounting No.	
9	16814 shall be deposited into the Treasury of the City and credited to Special Revenue Fund No.	
0	16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City	
1	and County of Denver.	
2	Section 3. Program expenditures are hereby as	uthorized for the "HOST Performance Contracts"

Fund, Accounting No. 16814, to be expended by the Executive Director of the Department of

Housing Stability. Allowable expenses will include performance-based payments to contractors providing programming including but not limited to housing and supportive case management services to homeless individuals who frequently use the City's emergency services, including police, jail, the courts, and emergency rooms. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund. This Fund is appropriated and non-lapsing. Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
