6 **For an ordinance establishing a new Fund in the General Government Special**
7 **Revenue Fund Series for the “Redaction Services” program.**

9 **WHEREAS**, the Clerk and Recorder is mandated to redact online records and images
10 containing certain personally identifiable information in accordance with state statutes; and

11 **WHEREAS**, Companion Ordinance 21-1307 includes a rescission from General Fund
12 Contingency to transfer cash to a new, non-lapsing Fund to administer a Redaction Services
13 project;

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
16 **OF DENVER:**

18 **Section 1.** A new Fund is hereby established in the General Government Special Revenue
19 Fund Series, Accounting No. 11000, a “Redaction Services” Fund, Accounting No. 11883, for the
20 purpose of accounting for the receipt and expenditure of program dollars.

21 **Section 2.** Monies received from General Fund transfers for Accounting No. 11883 shall be
22 deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which is
23 set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of
24 Denver.

25 **Section 3.** Program expenditures are hereby authorized for the “Redaction Services” Fund,
26 Accounting No. 11883, to be expended by the Clerk and Recorder. Allowable expenses include
27 costs to redact online records and images containing certain personally identifiable information in
28 accordance with state statutes. The Chief Financial Officer may transfer unused balances in the
29 Fund to the General Fund. This Fund is revenue-based and non-lapsing.

30 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
31 and directed to make such book and record entries and to do such other things as may be necessary
32 to accomplish the purposes of this Ordinance.
