A BILL

For an ordinance making rescissions from General Fund agency appropriations, making appropriations in the General Fund to make cash transfers, and making appropriations in the Capital Improvements and Capital Maintenances Fund and the General Government Special Revenue Fund.

WHEREAS, the City wishes to use 2021 savings from Denver Public Library, the Department of Parks and Recreation, and General Services to support the operating costs to implement ADA improvements agreed to through a settlement with the United States Department of Justice; and

WHEREAS, the City Council requested additional support to the Safe Routes to School program in the 2022 Budget, which can be accommodated by 2021 savings in the Department of Transportation and Infrastructure; and

WHEREAS, the Denver Sheriff Department has capital equipment needs in the jails that can be purchased through the 2021 savings; and

WHEREAS, the Municipal Public Defender wishes to use current year savings to expand the scope of the design plans at 710 Colfax Avenue to incorporate future staffing needs; and

WHEREAS, in order to use agency savings to support the above needs, rescissions and appropriations are needed to make cash transfers to other Funds;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

12 equipment for the Sheriff Department. The foregoing appropriation in the Transfer to Capital
13 Improvement Projects Fund is to make cash transfers to the Capital Improvement Program to
14 support a City Council 2022 Budget request for additional resources for Safe Routes to School,
15 and to support additional design at 710 Colfax Avenue to include space planning for future needs
16 by the Municipal Public Defender.
