## 2018 Bridge and Structural Construction Services On-Call Contract Amendment Fact Sheet

#### Department of Transportation and Infrastructure (DOTI) Bridge On-Call Construction

DOTI is seeking to maintain an already established group of qualified On-Call Prime General Contractors who are available to respond to proposal bidding requests for the execution of construction work for the City's infrastructure while the Bridge Group prepares the next on call RFQ.

## Purpose and Use of Agreements:

The purpose of these On-Call contracts is to establish and maintain a pool of qualified On-Call Prime General Contractors available to respond to proposal bidding requests for the execution of DOTI's Bridge Group's work plan. Each contract has a minimum 13% MWBE Performance goal creating up to \$3.25M in MWBE certified firm participation.

This On-Call is key to the City and County of Denver, DOTI Bridge group because bridge rehabilitation projects are performed by a specialized subset of contractors within the overall bridge contractor pool. This is critical to our workflow for rehabilitations and addressing bridge emergency repairs; both are needed as we attempt to achieve a state of good repair.

The Bridge and Structural Construction Services On-Call Contract will be utilized to construct a variety of improvements to the City and County of Denver's bridge infrastructure. These improvements may include but are not limited to minor bridge construction, major bridge rehabilitation and bridge replacements.

## Procurement:

The five firms were selected from a competitive RFQ procurement process. Six firms (6) submitted qualification submittals which were reviewed and scored. Of those submittals, five (5) firms were selected.

## **Contracts Description:**

Each contract will have two additional years and two million dollars for a total capacity of \$5 million. The firms selected for these agreements are listed alphabetically.
