14	WHEREAS, Ordinance No. 1413, Series of 2020, established the Climate Protection Fund
15	in the General Government Series to receive the sales tax revenue from the incremental increase
16	and to administer the program; and
17	WHEREAS, an allowable use of revenues for the Climate Protection Program includes
18	capital improvement projects; and
19	WHEREAS, Companion Ordinance 21-1212 establishes the Climate Protection Capital
20	Projects Fund in the Capital Improvements and Capital Maintenance Fund Series to receive
21	transfers from the Climate Protection Fund and administer capital projects that support climate
22	initiatives; and
23	WHEREAS, the City desires to transfer funds from the Climate Protection SRF to the
24	Climate Protection Capital Projects Fund to support Energy Performance Contracts as well as the
25	direct purchase of capital equipment;
