Our Mission

The Mission of the Colorado Coalition for the Homeless is to work collaboratively toward the prevention of homelessness and the creation of lasting solutions for families, children, and individuals who are experiencing or at-risk of homelessness throughout Colorado. CCH advocates for and provides a continuum of housing and a variety of services to improve the health, well-being and stability of those it serves.



- 1984 Colorado Coalition for the Homeless was as a 501(c)(3) non-profit corporation
- 1985 Stout Street Clinic opens
- 1988 First transitional housing opens for women and children
- 1990 CCH begins creating an affordable housing community with support services
- 1990-2000 472 units of housing were built or acquired
- 2000 CCH expands rural initiatives
- 2002 Opens first affordable housing rental property
- 2012 Offered integrated medical health, behavioral health and social services with housing
- 2013 CCH launches Fort Lyon recovery program
- 2014 New Stout Street Health Center opens
- 2016 CCH collaborates with the City and developers to launch SIB
- 2017 Renaissance Downtown Lofts opens
- **2018** CCH breaks ground on Fitzsimons project for veterans
- **2019:** COVID Response Contracts with and provides services at 6 motels in the Denver
- **2020:** Fusion Studios in north Denver and Renaissance Veterans Apartments at Fitzsimmons
- **2020:** Breaks ground on the Renaissance Legacy Lofts and Stout Street Recuperative Care Facility
- **2021:** Purchases La Quinta (now Park Ave. Inn)
- **2021:** U.S. Department of the Treasury offers the City and County of Denver \$6M under Social Impact Partnership to Pay for Results Act (SIPPRA)
- **2022:** Renaissance Legacy Lofts and Stout Street Recuperative Care Facility to open





- Formed as a Coalition of organizations responding to increased Homelessness in 1984.
- Opened Stout Street Clinic to meet heath care needs of those experiencing homelessness
- Focused initially on Denver, then Metro Denver and Statewide to advocate for policies to end homelessness
- 1995 we began our focus on CREATING LASTING SOLUTIONS TO HOMELESSNESS
- Utilizing best practices to address homelessness
- First Supportive Housing in Colorado
- First to use Housing First Approach
- First to implement integrated health care approach
- Looked to as an expert nationally

Integrated Healthcare Model


Treating multiple health issues




Denver Social Impact Bond Programs - For people who were experiencing chronic homelessness with frequent interactions with the criminal justice system and high use of emergency resources.








CCH REVENUE BY SOURCE -- 2010-2020

Masks/hygiene supplies, testing, and vaccines from street and medical outreach at encampments

Referral, Housing, and Healthcare services at Safe Outdoor Spaces

Transitions from hotel/motel sites to permanent housing

Milestones

1984: The Coalition is established at a 501(c)(3)

1985: Stout Street Clinic opens, becoming the first healthcare facility in Denver dedicated to serve individuals and families experiencing homelessness

1988: Ruth Goebel House opens

1990: Forest Manor in Aurora, the Coalition's first largescale affordable housing community with supportive services, opens

1992: The Coalition begins offering mental healthcare through the Project for Assistance in Transition from Homelessness (PATH) program

1993: The Quigg Newton Family Health Center, a collaborative project involving the Coalition, Denver Health, and the Denver Housing Authority, opens

1995: Rural Initiatives Program begins and Xenia Manor, 51 apartment homes in east Denver, opens

1996: An old office building is converted into the Forum Apartments, becoming the first permanent supportive housing program in Denver

1997: Loretto Heights in Englewood opens

1998: Renaissance at Concord Plaza in Lakewood opens

1999: Renaissance Children's Center and Beacon Place (veterans, respite) open

2000: The Coalition implements the Balance of State Continuum of Care

2002: The Health Outreach Program (HOP) launches and Renaissance Off Broadway Lofts, the first affordable rental loft development in Denver, opens

2003: The Coalition becomes the lead agency for the Denver Housing First Collaborative and the Renaissance Blue Spruce Townhomes at Lowry open

2004: The Coalition opens a new Dental Clinic and the Renaissance Civic Center Apartments

2005: The Coalition collaborates with the City and County of Denver on the 16th Street Housing First Program and the Denver Street Outreach Collaborative

2007: The Coalition redevelops the Renaissance 88 Apartments in Thornton and Renaissance at Xenia Village in Denver

2010: Renaissance Uptown Lofts open

2012: Renaissance West End Flats and West end Health Center open

2013: Fort Lyon Supportive Residential Community in Bent County opens

2014: Stout Street Health Center and Renaissance Stout Street Lofts open

2016: The Coalition collaborates with the City and County of Denver on the Social Impact Bond program and opens Renaissance North Colorado Station in north Denver

2018: Renaissance Downtown Lofts open (funded through SIB)

2019: The Coalition contracts with and provides services at 6 motels in the Denver metro area for Activated Respite and Protective Action purposes in response to the COVID-19 pandemic

2020: The Coalition opens Fusion Studios in north Denver and Renaissance Veterans Apartments at Fitzsimmons in Aurora and breaks ground on the Renaissance Legacy Lofts and Stout Street Recuperative Care Facility at its downtown campus

2021: The Coalition purchases La Quinta (now Park Ave. Inn) and the U.S. Department of the Treasury offers the City and County of Denver \$6M under Social Impact Partnership to Pay for Results Act (SIPPRA)

2022: Renaissance Legacy Lofts and Stout Street Recuperative Care Facility expected to open
