Denver enjoys a strong, committed, and diverse nonprofit sector that expands far beyond the relationships codified within contracts supported by the City. While City of Denver shares a leading role on issues such as housing, hunger, community development, climate, or the arts, it would not be able to achieve strength in response without formal or informal nonprofit partnerships. Further, while we are a prosperous city we are also a city challenged to bring equity within that prosperity—not least within the relationships and investments that meet organizational partnerships and the work grown in communities.

The trajectory of my service in City of Denver includes over a decade of professional service administering and directing strategies to serve our neighbors in homelessness, as well as long service as an appointee/elected chair of the Human Rights and Community Partnerships Advisory Board. During this time I have seen incredible growth in investment in our response to homelessness in particular. In 2011, when I began my career with the city at Denver's Road Home, our operating budget for homelessness response was around \$7mil. This year, dedicated investments are well into the hundreds of millions. Even as investments have grown, the challenges identified in the Office of Nonprofit Engagement's recent report remain — community-based organizations continue to struggle with organizational capacity to administer funded partnerships with the City, creating blended funding to sustain program budgets, accommodating delays in payment for services, and navigating contexts that should be collaborative rather than competitive.

My candidacy for the commission offers a voice at the table that has struggled with these barriers within the city, is hungry for new ways of doing business, and understands an urgency for change. I'm thankful for your consideration to recommend my appointment to the commission and am happy to assist in any capacity.
