Oracle Primavera was first procured in 2016 and a non-competitive sole-source contract to upgrade an obsolete software platform to Oracle Primavera. The original agreement included software development. This scope of work was eliminated in 2017. All purchase orders from 2017 to current have only been for software licensing and data hosting services. All software development is performed by other contracts with different consultants/companies

What is its anticipated lifespan?

Software service lifespan is specific to the service and varies with technology. With annual renewals and server maintenance, 7-14 years.

If there is an alternative source or an "approved, acceptable equal" to the good desired, why, for "practical purposes" can't the alternative or "equal" fulfill your needs?

There are several products and companies providing similar solutions, but the customization required for DEN business processes will take 10-18 months to develop, test, and implement

This solution has been in place since 2016 and no substantial investigation has been pursued for a replacement
