13	the Airport's Enterprise Series, Accounting No. 73000; and

16	WHEREAS, this fund will allow for DEN to centralize reporting and tracking the required			
17	contribution of art funds and corresponding projects at DEN; and			
18	WHEREAS, DEN requires a new Capital Project Fund to administer the Master Art program, as

24	Section 1. A new Fund is hereby established in the Denver Municipal Airport System Enterprise			
25	Fund Series, Accounting No. 73000, "Airport Capital Art Fund", Accounting No. 73853, for the			
26	purpose of accounting for the Denver Public Art Policy requirement of 1% contribution of art funds			
27	from eligible capital projects			
28	Section 2. Monies received from transfers from other funds, or other sources of revenue, shall			
29	be deposited into the Treasury of the City and credited to Special Fund No. 73000, which is set forth			
30	and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.			
31	Monies transferred from other DEN Enterprise Funds for the purpose of meeting the required Denver			
32	Public Art Policy from eligible capital projects are hereby authorized as projects are identified.			
33	Section 3. Expenditures are hereby authorized for the "Airport Capital Art" Fund, Accounting			
34	No. 73853, to be expended by the Manager of the Department of Aviation. Authorized expenditures

1	for Accounting No. 73853 are for the Master Art Program. This is a revenue-based and non-lapsing
