9	WHEREAS, in 2017, Denver voters approved Init	iated Ordinance 300, which was subsequently			
10	amended by Ordinance 1134, Series of 2018, that repealed and reenacted Article VIII of Chapter 10				
11	of the DRMC, the Green Building Ordinance; and				
12	WHEREAS, Ordinance 1141, Series of 2018 created the Green Building Capital Fund to fund				
13	capital projects related to the Green Building program, and				
14	WHEREAS, primary revenue to this Fund is developer payments, fees in-lieu of compliance				
15	with the Green Building Ordinance; and				
16	WHEREAS, a new Green Building Program Special Revenue Fund (SRF) is being				
17	established by CB22-0137, which will serve as the primary Green Building Fund, and thus will				
18	receive the developer fee revenue; and				
19	WHEREAS, said new SRF will transfer funds to	o the Green Building Capital Fund via the			
20	budget and ordinance processes as Green Building Capital Projects are identified by CASR,				
21	WHEREAS, the City wishes to amend Ordinance 1141, Series of 2018, to change the name				
22	of Capital Fund 38604, clarify the expending authority, and to remove developer fees as allowable

26	NOW, THEREFORE, BE IT ENACTED BY TH	E COUNCIL OF THE CITY AND COUNTY

29	Section 1. Sections 1 - 3 of Ordinance No. 1141,	Series of 2018 is hereby amended to read as			
30	follows:				
31	"Section 1. A new fund is hereby esta	ablished in the Grant and Other			
32	Money Projects Fund, Accounting No. 380	000, a "Green Building Capital			

Fund," Accounting No. 38604, for the purpose of accounting for the receipt and expenditure of capital program dollars.

Section 2. Monies received from other City funds and other sources of revenue for Accounting No. 38604, shall be deposited into the Treasury of the City and credited to Special Projects Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. Program expenditures are hereby authorized for the "Green Building Capital Fund," Accounting No. 38604, in the amount not to exceed the total of deposits described in Section 2 of this ordinance, to be expended by the Director of the Office of Climate Action, Sustainability, and Resiliency. Authorized expenditures for Accounting No. 38604 include acquisition of green space within the city, improvements for existing green space, water quality improvements and green infrastructure, urban forest protection and expansion, green roof creation, and solar adoption and energy efficiency projects in areas of low-income and affordable housing populations. This is a cash basis, non-lapsing fund."

Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
