SECOND AMENDATORY AGREEMENT

This **SECOND AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City") and **JEFFERSON COUNTY SHERIFF'S OFFICE**, whose address is 200 Jefferson County Pkwy, Golden, Colorado 80419 (the "Contractor"), jointly ("the Parties").

RECITALS:

- A. The Parties entered into Agreement dated April 5, 2016, and a First Amendatory Agreement dated May 14, 2019 (collectively, the "Agreement") to provide uniformed patrol services within Denver's Mountain Parks.
- **B.** The Parties wish to amend the Agreement to extend the term and increase the maximum contract amount.

NOW THEREFORE, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

- 1. All references to "...Exhibit A and A-1..." in the Agreement shall be amended to read: "...Exhibit A, A-1 and A-2..." as applicable. The scope of work marked as **Exhibit A-2** attached to this Second Amendatory Agreement is hereby incorporated by reference.
- 2. Section 5 of the Agreement entitled **TERM** is hereby deleted in its entirety and replaced with:

"5. TERM:

This IGA will commence on January 1, 2016 and will expire on December 31, 2031 (the "Term"), unless earlier terminated as provided herein. Any extension of this IGA must be by written amendment between the Parties and is subject to annual appropriation of funds by the City."

3. Section 7 of the Agreement entitled **MAXIMUM CONTRACT AMOUNT:** is hereby deleted in its entirety and replaced with:

'a. MAXIMUM CONTRACT AMOUNT:

Notwithstanding any other provision of this IGA, the City's maximum payment obligation will not exceed FOUR MILLION TWO HUNDRED SIXTEEN THOUSAND THIRTY-SIX DOLLARS AND NO CENTS (\$4,216,036.00). The City is not obligated to execute an IGA or amendments for any further services, including any services performed by JCSO beyond those specifically described in Exhibits A, A-1 and exhibits

- A-2. Any services performed beyond those listed are performed at JCSO's risk and without authorization under this IGA."."
- 4. As herein amended, the Agreement is affirmed and ratified in each and every particular.
- 5. This Second Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
