REVOCABLE LICENSE (4201 Monroe Street)

THIS LICENSE is entered into by and between the CITY AND COUNTY OF DENVER, a home rule city and municipal corporation of the State of Colorado ("City") and COLORADO VILLAGE COLLABORATIVE, a Colorado Nonprofit Corporation, with a an address of 3264 Larimer Street, Unit D, Denver, CO 80205 ("Licensee").

NOW, THEREFORE, in consideration of the promises and the mutual covenants and obligations set forth herein, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Licensee and City agree as follows

1. <u>GRANT, TERM, AND SCOPE OF WORK</u>: The City grants to the Licensee, its Licensees, sublicensees, agents and invitees, subject to the conditions and terms in this License Agreement, a non-exclusive revocable License to use portions of land located at **4201 Monroe Street, Denver, CO 80216** (as depicted in **Exhibit A**, attached hereto and incorporated by this reference (the "**Premises**" or "**Licensed Premises**"). This Agreement shall commence as of the Effective Date of this Revocable License Agreement and shall be in effect for twenty-four (24) months with two (2) additional one (1) year extensions exercisable only by the City, subject to the conditions and terms in this License. Through this Agreement, City grants Licensee an exclusive, revocable license to establish a tiny home village site in a portion of a City owned land which will be known as the **Allowable Use**, more specifically described in the clause titled "**USE**" later in this Agreement (the "**Allowable Use**") and in **Exhibit B**, attached.

2. <u>FEE</u>: Licensee agrees to pay the City a fee of **TEN DOLLARS AND ZERO CENTS (\$10.00)** annually (the "**License Fee**"), payable concurrently with the execution of the License by Licensee. All payments hereunder shall be delivered to:

3. <u>**REVOCATION AND RETAINED RIGHTS OF CITY**</u>: The City retains the absolute right to revoke the License for any reason, upon fifteen (15) days written notice to Licensee. Revocation shall be in writing signed by the Director of Real Estate (the "Director") and delivered to Licensee. The City reserves the right to own and occupy the Premises in any

manner that does not unreasonably interfere with the exercise of the rights granted by this License.

4. <u>USE OF PREMISES</u>: As a condition of the License, Licensee shall use the Premises as follows:

Use. The Allowable Use shall be for the use of a tiny home village with a. no more than twenty-six (26) structures on site, as set forth on **Exhibit A** and no other purpose; expressly excluding any outdoor camping or continued occupancy outside of a tiny home structure. The structures of the village will be uniform in color and style and the Licensee shall erect an eight (8) foot tall chain-link fence along the parameter of the site, as depicted in Exhibit A. Licensee will staff the site 10 hours per day, 7 days per week. The Licensee will conduct all activities in the Licensed Premises in accordance with this License and in full compliance with the terms of associated City and Colorado Village Collaborative service agreement (HOST-202157471), as well as all current applicable laws and rules and regulations regarding such services then in effect. License will maintain in good standing any required licenses and permits, and shall immediately notify the City if any investigation is commenced, or any action is taken, by any governmental agency in respect of such license or permit, including without limitation, the suspension or revocation thereof. The Licensee shall use the Licensed Premises in a careful, safe and proper manner and shall not use or permit the Licensed Premises to be used for any purpose prohibited by the laws of the United States of America, the State of Colorado, or the Charter or ordinances of the City and County of Denver. The Licensee shall not commit or suffer to be committed any waste or damage upon the Licensed Premises or any nuisance to be created or maintained thereon. The Licensee shall also keep the Licensee Premises free and clear from all trash, debris and waste resulting from its use or the use by its employees, officers, agents, invitees and visitors.

b. <u>Other Permits</u>. Prior to commencement date of the License, Licensee shall obtain all necessary federal, state, and local permits for the use of the Premises. Licensee shall comply with all applicable laws, rules, or regulations of the City. Nothing in this License shall relieve Licensee from complying with other regulatory requirements applicable to the License and the Allowable Use.

c. <u>Damage or Injury</u>. The City shall not be responsible or liable for injuries to persons or damage to property when such injuries or damage are caused by or result from the Licensee's use of the Premises under the terms of this License.

d. <u>Good Neighbor Agreement.</u> In good faith, Licensee will make efforts to negotiate a Neighborhood Community Agreement within fourteen (14) days of execution of this Agreement.

e. <u>Expanded Premises Option</u>. City, in its sole discretion, has the option to permit Licensee to expand this service onto the adjacent City-owned premises located at 4001 North Monroe Street at any time during the term of this Agreement. Should this expansion occur, all requirements contained herein, such as staffing and fencing around the perimeter of the village, shall apply to the expanded village.

f. <u>Annual Report</u>. Licensee must submit a report annually, no later than December 31st of each calendar year, to the Director of Real Estate. Such report must address:

- (a) The continued public purpose and benefit to the City of Licensee's operations on the leased property.
- (b) Description of Licensee's use of the property in the past / current year.
- (c) Operational / Program Plans for the current / coming year.

5. <u>TERMINATION</u>: Either party may terminate this Agreement upon thirty (30) days written notice to the other party. In the event this License is canceled, terminated or revoked by either party before the expiration of its term, the Licensee shall at its sole expense remove any personal property from the Premises, and shall restore the Premises to the extent required by the Director. The provisions of the clause titled "<u>DAMAGE TO CITY PROPERTY</u>" shall apply to any damage to the Licensed Premises. In any event, termination, or expiration of the related service agreement (HOST-202157471) or any of its amendments, shall result in a termination of this License, unless the parties by written document, choose to extend the License.

6. <u>ENTRY BY CITY</u>: Licensee shall permit representatives of the City to enter upon the Premises after receiving twenty-four (24) hour prior notice from the City to inspect the same, except in the case of City provided emergency services, the City may enter upon the Premises without any prior notice.

7. <u>NO COST TO CITY</u>: The exercise of the privileges granted by this License shall be without cost or expense to the City, other than expenses described in Section Seven.

8. <u>MAINTENANCE AND UTILITIES</u>: Licensee, at its sole cost, will provide and pay for its operating expenses, including utilities, phone bills, internet, laundry, tiny home maintenance and repairs, litter pickup, snow removal and trash hauling at the Premises. In addition to the foregoing, the Licensee, at its sole cost and expense, shall be responsible for maintaining the Premises during the term of this License and shall keep the Premises free and clear from all trash, debris, and waste resulting from its use or the use by its employees, volunteers, officers, agents, invitees and visitors.

9. <u>DAMAGE TO CITY PROPERTY</u>: Any property of the City damaged or destroyed by Licensee incident to the use of this License shall be promptly repaired or replaced by Licensee to the satisfaction of the Director. The Director may, at his/her option, in lieu of such repair or replacement, require Licensee to pay to the City money in an amount sufficient to compensate for the loss sustained by the City for any damage that may result from the Allowable Use.

10. <u>COMPLIANCE WITH ENVIRONMENTAL REQUIREMENTS</u>: Licensee shall comply with all applicable local, state, and federal environmental rules, regulations, statutes, laws or orders (collectively, "Environmental Requirements"), including but not limited to Environmental Requirements regarding the storage, use and disposal of Hazardous Materials and regarding releases or threatened releases of Hazardous Materials to the environment. For purposes of this License, the terms "Hazardous Materials" shall mean asbestos and asbestos-containing materials, special wastes, polychlorinated biphenyls (PCBs), any petroleum products, natural gas, radioactive source material, pesticides and any hazardous waste as defined at 42 U.S.C. § 6903(5) of the Solid Waste Disposal Act, or the Colorado law governing hazardous waste C.R.S.§25-15-101, et seq., any hazardous substance as defined at 42 U.S.C. § 9601(14) of the Comprehensive Environmental Response, Compensation and Liability Act, and chemical substance as defined at 15 U.S.C.§ 2602(2) of the Toxic Substances Control Act, and any rules or regulations promulgated pursuant to such statutes or any other applicable federal or state statute.

11. <u>INSURANCE</u>:

- General Conditions: Licensee agrees to secure, at or before the time of a. execution of this Agreement, the following insurance covering all operations, goods or services provided pursuant to this Agreement. Licensee shall keep the required insurance coverage in force at all times during the term of the Agreement, including any extension thereof, and during any warranty period. The required insurance shall be underwritten by an insurer licensed or authorized to do business in Colorado and rated by A.M. Best Company as "A-VIII" or better. Each policy shall require notification to the City in the event any of the required policies be canceled or non-renewed before the expiration date thereof. Such written notice shall be sent to the parties identified in the Notices section of this Agreement. Such notice shall reference the City contract number listed on the signature page of this Agreement. Said notice shall be sent thirty (30) days prior to such cancellation or non-renewal unless due to non-payment of premiums for which notice shall be sent ten (10) days prior. If such written notice is unavailable from the insurer, Licensee shall provide written notice of cancellation, nonrenewal and any reduction in coverage to the parties identified in the Notices section by certified mail, return receipt requested within three (3) business days of such notice by its insurer(s) and referencing the City's contract number. Licensee shall be responsible for the payment of any deductible or self-insured retention. The insurance coverages specified in this Agreement are the minimum requirements, and these requirements do not lessen or limit the liability of the Licensee. The Licensee shall maintain, at its own expense, any additional kinds or amounts of insurance that it may deem necessary to cover its obligations and liabilities under this Agreement.
- b. Proof of Insurance: Licensee may not commence services or work relating to this Agreement prior to placement of coverages required under this Agreement. Licensee certifies that the certificate of insurance attached as Exhibit C, preferably an ACORD form, complies with all insurance requirements of this Agreement. The City requests that the City's contract number be referenced on the certificate of insurance. The City's acceptance of a certificate of insurance or other proof of insurance that does not comply with all insurance requirements set

forth in this Agreement shall not act as a waiver of Licensee's breach of this Agreement or of any of the City's rights or remedies under this Agreement. The City's Risk Management Office may require additional proof of insurance, including but not limited to policies and endorsements.

- c. Additional Insureds: For Commercial General Liability, Auto Liability and Excess Liability/Umbrella (if required), Licensee and subLicensee's insurer(s) shall include the City and County of Denver, its elected and appointed officials, employees and volunteers as additional insured.
- d. **Waiver of Subrogation:** For all coverages required under this Agreement, Licensee's insurer shall waive subrogation rights against the City.
- e. **Subcontractors and Subconsultants:** Licensee shall confirm and document that all subcontractors and subconsultants (including independent contractors, suppliers or other entities providing goods or services required by this Agreement) procure and maintain coverage as approved by the Licensee and appropriate to their respective primary business risks considering the nature and scope of services provided.
- f. **Workers' Compensation and Employer's Liability Insurance:** Licensee shall maintain the coverage as required by statute for each work location and shall maintain Employer's Liability insurance with limits of \$100,000 per occurrence for each bodily injury claim, \$100,000 per occurrence for each bodily injury caused by disease claim, and \$500,000 aggregate for all bodily injuries caused by disease claims.
- g. **Commercial General Liability:** Licensee shall maintain a Commercial General Liability insurance policy with minimum limits of \$1,000,000 for each bodily injury and property damage occurrence, \$2,000,000 products and completed operations aggregate (if applicable), and \$2,000,000 policy aggregate.
- Automobile Liability: Licensee shall maintain Automobile Liability with minimum limits of \$1,000,000 combined single limit applicable to all owned, hired and non-owned vehicles used at the Licensed Premises.
- Property Insurance: Licensee shall provide 100% replacement cost for Licensee's improvements and personal property. Business Interruption coverage Colorado Village Collaborative - License Agreement Jaggaer CCN: FINAN-202161442

shall be included with limits not less than the annual payments due to the City under the term of the agreement. Licensee understands and acknowledges that the City does not provide any insurance coverage for any property of the Licensee, its agents, employees or assignees located in the Licensed Premises and Licensee acknowledges and agrees that the Licensee, its agents, employees and assignees have no claim against the City for any damage or loss of personal property and belongings of Licensee, its agents, employees or assignees in the Licensed Premises.

12. <u>DEFENSE AND INDEMNIFICATION</u>:

a. Licensee hereby agrees to defend, indemnify, reimburse and hold harmless City, its appointed and elected officials, agents and employees for, from and against all liabilities, claims, judgments, suits or demands for damages to persons or property arising out of, resulting from, or relating to the work performed under this License ("Claims"), unless such Claims have been specifically determined by the trier of fact to be the sole negligence or willful misconduct of the City. This indemnity shall be interpreted in the broadest possible manner to indemnify City for any acts or omissions of Licensee or its subLicensees either passive or active, irrespective of fault, including City's concurrent negligence whether active or passive, except for the sole negligence or willful misconduct of City.

b. Licensee's duty to defend and indemnify City shall arise at the time written notice of the Claim is first provided to City regardless of whether Claimant has filed suit on the Claim. Licensee's duty to defend and indemnify City shall arise even if City is the only party sued by claimant and/or claimant alleges that City's negligence or willful misconduct was the sole cause of claimant's damages.

c. Licensee will defend any and all Claims which may be brought or threatened against City and will pay on behalf of City any expenses incurred by reason of such Claims including, but not limited to, court costs and attorney fees incurred in defending and investigating such Claims or seeking to enforce this indemnity obligation. Such payments on behalf of City shall be in addition to any other legal remedies available to City and shall not be considered City's exclusive remedy.

d. Insurance coverage requirements specified in this License shall in no way lessen or limit the liability of the Licensee under the terms of this indemnification obligation. Colorado Village Collaborative - License Agreement Jaggaer CCN: FINAN-202161442

The Licensee shall obtain, at its own expense, any additional insurance that it deems necessary for the City's protection.

e. This defense and indemnification obligation shall survive the expiration or termination of this License.

13. <u>NOTICES</u>: All notices required to be given to the City or Licensee shall be in writing and sent by certified mail, return receipt requested, to:

Any party may designate in writing from time to time the address of substitute or additional persons to receive such notices. The effective date of service of any such notice is the date on which mailed or personally delivered.

14. <u>LICENSEE EMERGENCY CONTACT DESIGNATION</u>: Licensee hereby designates Cole Chandler who shall be available twenty-four hours a day, seven days a week to receive any calls from the City with respect to any emergencies or urgent concerns that may arise under this License. Licensee may designate in writing from time to time the substitute or additional person to receive such calls from the City.

15. <u>**COMPLIANCE WITH LAWS**</u>: All persons or entities utilizing the Premises pursuant to this License shall observe and comply with the applicable provisions of the Charter, ordinances, and rules and regulations of the City and with all applicable Colorado and federal laws.

16. <u>SEVERABILITY</u>: The promises and covenants contained in this License are several in nature. Should any one or more of the provisions of this License be judicially adjudged invalid or unenforceable, such judgment shall not affect, impair, or invalidate the remaining provisions of the License.

17. <u>APPLICABLE LAW/VENUE</u>: Each and every term, condition, or covenant of this Easement is subject to and shall be construed in accordance with the provisions of Colorado law, any applicable federal law, the Charter of the City and County of Denver, and the ordinances, regulations, and Executive Orders enacted and/or promulgated pursuant to the Charter. The applicable law, together with the Charter, Revised Municipal Code and regulations of the City and County of Denver, as the same may be amended from time to time, are expressly incorporated into this License as if fully set out by this reference. Venue for any action relating to this License shall be in the State District Court in the City and County of Denver, Colorado.

18. <u>NO DISCRIMINATION</u>: In connection with the performance of an Allowable Use under this License, Licensee may not refuse to hire, discharge, promote, demote, or discriminate in matters of compensation against any person otherwise qualified, solely because of race, color, religion, national origin, ethnicity, citizenship, immigration status, gender, age, sexual orientation, gender identity, gender expression, marital status, source of income, military status, protective hairstyle, or disability. The Licensee shall insert the foregoing provision in all subcontracts.

19. <u>ENTIRE LICENSE</u>: This License is the complete integration of all understandings between the Parties. No prior or contemporaneous addition, deletion, or other modification shall have any force or effect, unless embodied in this License in writing.

20. <u>AMENDMENTS</u>: No subsequent novation, renewal, addition, deletion, or other amendment shall have any force or effect unless embodied in a written amendment to this License properly executed by the parties. No oral representation by any officer or employee of the City at variance with the terms and conditions of this License or any written amendment to this License shall have any force or effect nor bind the City. This License and any amendments to it shall be binding upon the Parties and their successors and assigns.

21. <u>AUTHORITY</u>: Licensee represents and warrants that the person signing this License has the authority to execute and deliver this License on behalf of Licensee.

22. <u>APPROPRIATION</u>: All obligations of the City under and pursuant to this License are subject to prior appropriations of monies expressly made by the City Council for the purposes of this License and paid into the Treasury of the City.

23. <u>CONFLICT OF INTEREST BY CITY OFFICERS</u>: Licensee represents that to the best of its information and belief no officer or employee of the City is either directly or indirectly a party to or in any manner interested in this License except as such interest may arise as a result of the lawful discharge of the responsibilities of such elected official or employee.

24. <u>NO PERSONAL LIABILITY</u>: No elected official, director, officer, agent, or employee of the City shall be charged personally or held contractually liable under any term or provision of this License or because of any breach thereof or because of its or their execution, approval, or attempted execution of this License.

25. **EXAMINATION OF RECORDS AND AUDITS**: Any authorized agent of the City, including the City Auditor or his or her representative, has the right to access, and the right to examine, copy and retain copies, at City's election in paper or electronic form, any pertinent books, documents, papers and records related to the Licensee's performance pursuant to this Agreement, provision of any goods or services to the City, and any other transactions related to this Agreement. The Licensee shall cooperate with City representatives and City representatives shall be granted access to the foregoing documents and information during reasonable business hours and until the latter of three (3) years after the final payment under the Agreement or expiration of the applicable statute of limitations. When conducting an audit of this Agreement, the City Auditor shall be subject to government auditing standards issued by the United States Government Accountability Office by the Comptroller General of the United States, including with respect to disclosure of information acquired during the course of an audit. No examination of records and audits pursuant to this paragraph shall require the Licensee to make disclosures in violation of state or federal privacy laws. The Licensee shall at all times comply with D.R.M.C. 20-276.

26. <u>ELECTRONIC SIGNATURES AND ELECTRONIC RECORDS</u>: Licensee consents to the use of electronic signatures by the City. The License, and any other documents requiring a signature hereunder, may be signed electronically by the City in the manner specified by the City. The Parties agree not to deny the legal effect or enforceability of the License solely because it is in electronic form or because an electronic record was used in its formation. Parties agree not to object to the admissibility of the License in the form of an electronic record, or a paper copy of an electronic document, or a paper copy of a document bearing an electronic signature, on the ground that it is an electronic record or electronic signature or that it is not in its original form or is not an original.

27. <u>EFFECTIVE DATE.</u> The Effective Date shall be the date the City delivers a fully executed copy of this Agreement to the Licensee.





 - (b) To meet seasonal or short-term workload conditions;

while that person is subject to your direction and control and performing services for you.

- (3) "Employee" does not mean:
 - (a) Any agent, broker, person leased to you by a labor leasing firm, factor, commission merchant, consignee, independent contractor or representative of the same general character; or
 - (b) Any "manager," director or trustee except while performing acts coming within the scope of the usual duties of an "employee."
- c. "Manager" means a person serving in a directorial capacity for a limited liability company.

L. Additional Insureds

SECTION II – WHO IS AN INSURED is amended as follows:

- f. Managers, Landlords, or Lessors of Premises Any person or organization with respect to their liability arising out of the ownership, maintenance or use of that part of the premises leased or rented to you subject to the following additional exclusions:

This insurance does not apply to:

- (2) Structural alterations, new construction or demolition operations performed by or on behalf of that person or organization.
- g. Lessor of Leased Equipment Automatic Status When Required in Lease Agreement With You – Any person or organization from whom you lease equipment when you and such person or organization have agreed in writing in a contract or agreement that such person or organization is to be added as an additional insured on your policy.  - (c) The ownership, maintenance, or use of any elevators covered by this insurance.
- i. **Vendors** Only with respect to "bodily injury" or "property damage" arising out of "your products" which are distributed or sold in the regular course of the vendor's business, subject to the following additional exclusions:
 - (1) The insurance afforded the vendor does not apply to:
 - (a) "Bodily injury" or "property damage" for which the vendor is obligated to pay damages by reason of the assumption of liability in a contract or agreement. This exclusion does not apply to liability for damages that the vendor would have in the absence of the contract or agreement;
 - (b) Any express warranty unauthorized by you;
 - (c) Any physical or chemical change in the product made intentionally by the vendor;
 - (d) Repackaging, except when unpacked solely for the purpose of inspection, demonstration, testing, or the substitution of parts under instructions from the manufacturer, and then repackaged in the original container;
 - (e) Any failure to make such inspections, adjustments, tests or servicing as the vendor has agreed to make or normally undertakes to make in the usual course of business, in connection with the distribution or sale of the products;
 - (f) Demonstration, installation, servicing or repair operations, except such operations performed at the vendor's premises in connection with the sale of the product;

- (g) Products which, after distribution or sale by you, have been labeled or relabeled or used as a container, part or ingredient of any other thing or substance by or for the vendor; or
- (h) "Bodily injury" or "property damage" arising out of the sole negligence of the vendor for its own acts or omissions or those of its employees or anyone else acting on its behalf. However, this exclusion does not apply to:
 - (i) The exceptions contained in Sub-paragraphs (d) or (f); or
 - (ii) Such inspections, adjustments, tests or servicing as the vendor has agreed to make or normally undertakes to make in the usual course of business, in connection with the distribution or sale of the products.

- 2. SECTION V DEFINITIONS, Paragraph 14. is amended by adding the following:

Discrimination based on race, color, religion, sex, age or national origin, except when:

- a. Done intentionally by or at the direction of, or with the knowledge or consent of:
 - (1) Any insured; or
 - (2) Any executive officer, director, stockholder, partner or member of the insured;
- Directly or indirectly related to the employment, former or prospective employment, termination of employment, or application for employment of any person or persons by an insured;

- **c.** Directly or indirectly related to the sale, rental, lease or sublease or prospective sales, rental, lease or sub-lease of any room, dwelling or premises by or at the direction of any insured; or
- **d.** Insurance for such discrimination is prohibited by or held in violation of law, public policy, legislation, court decision or administrative ruling.

The above does not apply to fines or penalties imposed because of discrimination.

Getting paper copies
