FOR AN ORDINANCE VACATING A CERTAIN PART OF THE SYSTEM OF THOROUGHFARES OF THE SYSTEM OF THOROUGHFARES OF THE MUNICIPALITY: I.E., VACATING OF ALLEY LYING BETWEEN LOTS 1 AND 20, JACOBS ADDITION TO HIGHLAND, THE BLOCK IS BOUNDED BY WEST COLFAX AVENUE, MORRISON ROAD, VACATED WEST 14TH AVENUE AND CANOSA COURT, SUBJECT TO CERTAIN RESERVATIONS.

The alley between Lots 1 and 20, Jacobs Addition to Highland, lying between the southeasterly line of Morrison Road (County Road No. 6) and the westerly line of Lot 8, Ashton.

be and the same is hereby approved and the described alley is hereby vacated and declared vacated, provided, however, said vacation shall be subject to the following conditions and reservations:

That easements be and are hereby retained to protect the utilities in the vacated alley which utilities include power and telephone lines.
