12	Section 1. That section 20-276 of the Denver Revised Municipal Code shall be amended
13	by deleting the language stricken to read as follows:

15	(a) The auditor shall be provided access, in a timely manner to officers, employees,
16	records, and property of entities as may be necessary to conduct an audit or perform audit
17	duties as provided in section 20-275 of the D.R.M.C. Contractors with the City that have a
18	contractual obligation to provide information shall provide access in a timely manner to the
19	contractor's officers, employees, records, and property of entities as may be necessary to
20	conduct an audit or perform audit duties. The custodian of confidential and/or proprietary records
21	or parts of records sought under this 20-276 may provide the auditor timely and reasonable
22	access to inspect such records on site in lieu of providing copies for off-site use.
23	Section 2. That section 20-278 of the Revised Municipal Code, entitled "Records and
24	subpoenas" and relating to Auditor subpoena power is hereby repealed.
25	Section 3. That section 20-279 of the Denver Revised Municipal Code shall be
26	amended and reorganized by adding the language underlined and deleting the language
27	stricken to read as follows:
28	Sec. 20-27 <u>98</u> Auditor's annual budget.
29	Section 4. That section 20-280 of the Denver Revised Municipal Code shall be

Sec. 20-2<del>80</del>79. – Audit committee terms and vacancies.

1	<b>Section 5.</b> That section 20-281 of the Denver Revised Municipal Code shall be
