6 7 8	For an ordinance changing the zoning classification for 8101 & 8351 East Belleview Avenue in Hampden South.
9	WHEREAS, the City Council has determined, based on evidence and testimony presented at
10	the public hearing, that the map amendment set forth below conforms with applicable City laws, is
11	consistent with the City's adopted plans, furthers the public health, safety and general welfare of the
12	City, will result in regulations and restrictions that are uniform within the S-MX-8 district, is justified
13	by one of the circumstances set forth in Section 12.4.10.8 of the Denver Zoning Code, and is
14	consistent with the neighborhood context and the stated purpose and intent of the proposed zone
15	district;
16	NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
17	DENVER:
18	Section 1. That upon consideration of a change in the zoning classification of the land area
19	hereinafter described, Council finds:
20	a. The land area hereinafter described is presently classified as B-8 with waivers and
21	conditions, UO-1, UO-2 and B-8 with waivers, UO-1, UO-2.
22	b. It is proposed that the land area hereinafter described be changed to S-MX-8.
23	Section 2. That the zoning classification of the land area in the City and County of Denver
24	described as follows shall be and hereby is changed from B-8 with waivers and conditions, UO-1, UO-
25	2 and B-8 with waivers, UO-1, UO-2 to S-MX-8:
26	Parcel 1:
27 28 29	A tract of land in the Southeast $\frac{1}{4}$ of Section 9, Township 5 South, Range 67 West of the 6th Principal Meridian, City and County of Denver, State of Colorado, more particularly described as follows:
30	Commencing at the Southwest corner of said Southeast 1/4;
31	Thence East along the South line of said Southeast ¼, 664.91 feet;
32 33	Thence on an angle to the left of 89°33'46" and parallel with the West line of said Southeast $\frac{1}{4}$, 70.00 feet to the True Point of Beginning;
34	Thence continuing along the same course an additional distance of 726.00 feet;
35 36	Thence on an angle to the left of $90^{\circ}26'14''$ and parallel with said South line of the Southeast $\frac{1}{4}$, 584.91 feet;

- Thence on an angle to the left of 89°33'46" and parallel with said West line of the Southeast 1/4, 65.00 feet;
- Thence on an angle to the right of 89°33'46" and parallel with said South line of the Southeast ¼, 20.00 feet;
- Thence on an angle to the left of 89°33'46" and parallel with said West line of the Southeast 1/4, 558.72 feet to a point of curvature;
- Thence along a curve to the left having a radius of 101.50 feet and a central angle of 90°26'14", an arc distance of 160.21 feet to a point of tangency;
 - Thence along the tangent to the aforesaid curve, parallel with and 70.00 feet North of said South line of the Southeast ¼ of Section 9, 502.63 feet to the True Point of Beginning.
