

Proclamation No. 22-0339 Honoring the Life of Margaret Chavez

WHEREAS, in February of 1980 President Jimmy Carter signed an executive order recognizing March as Women's History Month; and

**WHEREAS**, since 1890 women have played and continue to play a vital role in the operations and direction of the Denver Police Department; and

**WHEREAS**, the Denver Police Museum and the Denver Police Department have partnered to celebrate Women's History Month 2022 in honoring Sgt. Margaret Chavez; and

WHEREAS, Officer Margaret Chavez started her law enforcement career at the Northglenn Police Department in 1970 and later served at the Jefferson County District Attorney's Office in 1980; and

WHEREAS, Margaret Chavez was born Margaret McCumiskey in Denver 1940; and

WHEREAS, Margaret Chavez was educated in the Denver Public Schools attending Beach Court Elementary, Horace Mann Middle School, and graduated from North High School, attended Metropolitan State College; and

WHEREAS, in June 1959 Margaret Chavez married Anthony "Snooky" Acierno, with whom they had two children, Dena and Anthony "Snooky" Acierno Jr; and

WHEREAS, in 1970 Margaret Chavez married Denver Police Officer Kenny Chavez; and

WHEREAS, Margaret Chavez joined the Denver Police Department in 1985; and

**WHEREAS**, Margaret Chavez was assigned to patrol in Denver Police District 3 in 1986, to patrol in Denver Police District 2 in late 1986, and she would return to District 3 in 1990; and

WHEREAS, Margaret Chavez would serve as a DARE instructor in 1992, and as a recruiter for the department in 1994, and later served as a Public Information Officer under the administration of Chief David Michaud in 1996; and

WHEREAS, in 1998 Margaret Chavez was promoted to Sergeant where she would eventually serve in District 6 as a Patrol Sergeant; and

WHEREAS, in 2001 Sergeant Chavez would lead in Auto Theft and Property Crimes Units and in 2003 would serve as District 3's Sergeant of Detectives; and

WHEREAS, in 2005 Sgt. Margaret Chavez retired from the Denver Police Department; and

## NOW THEREFORE, BE IT PROCLAIMED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. the Denver City Council wishes to recognize retired Sgt. Margaret Chavez for her groundbreaking role while serving and protecting the citizens of the City and County of Denver.

**Section 2.** That the Clerk of the City and County of Denver shall affix the seal of the City and County of Denver to this proclamation and that a copy be transmitted to Margaret Chavez.
