DEN UPDATE



- Preliminary numbers from ACI show that DEN finished 2021 as the 3rd busiest in the world
- February 2022 was the first month passenger numbers exceeded 2019 numbers
- Expecting a busy summer with passenger numbers close to or exceeding 2019 numbers
- Since fall 2021, DEN has added four security lanes, for a total of 32, for use by TSA as staffing levels allow
- Currently finalizing Capital Improvement Plan (CIP) and will present it to you in Q2 2022
- Will update City Council on the Center for Excellence and Equity in Aviation in May 2022
- Will celebrate the completion of the 16 new gates on C-east on May 5 at 2 p.m.
- Celebrated the opening of the Southwest hangar on March 24
- Recently made some organizational changes to better address asset management
 - The Asset Management team has been moved under Chief Operating Officer Steve Jaquith
 - Will be hiring a Senior Director of Asset Management

FRONTIER USE AND LEASE AGREEMENT



- Frontier has signed a new Use and Lease Agreement with DEN
- Will increase its preferential leasehold to 14 gates after the construction of an extension to the Concourse A Ground Load Facility
- All gates will be ground loaded, allowing for front and rear enplaning and deplaning of customers
- Term of the lease is 10 years from the date that the airline occupies the new facility, currently estimated in the first half of 2024
- Pending approval from the Federal Aviation Administration, DEN plans to use Passenger Facility Charges for the construction of the Concourse A Ground Load Facility extension
- DEN has agreed to a credit that will allow for Frontier's rent to remain flat on a per gate basis to their Concourse level nine-gate leasehold

FRONTIER HANGAR AMENDMENT




- We are requesting an amendment to the hangar lease between DEN and Frontier
- The new ground lease will reflect the true ground that the airline is occupying in the hangar area of the north campus
- All other terms of the agreement remain the same for the duration of the hangar lease

GATE EXPANSION PROGRAM AMENDMENTS

- Amendments will allow for the following additional work:
 - A-East Ground Load Expansion for Frontier lease
 - B-East hot water failure repairs and schedule requirements
 - Phase 1 of DS taxiway to provide needed de-ice capacity
 - Gate apron rehabilitation
- Contracts to be amended:
 - Turner Flatiron JV
 - Holder FCI JV
 - Jacobs Engineering
 - HTNB
 - WSP USA

- Amending the existing contracts will expedite work to meet Frontier needs, provide operational efficiency and save money
- Although prime contractors won't change, a majority of work will still be bid out to subcontractors



A-EAST GROUND LOAD EXPANSION




- Budget \$183M
- Provides 14 ground load gates to satisfy Frontier lease
- Includes jet fueling, maintenance facility, office space, new elevator, new escalator, new holdroom and existing hold room modifications
- Target occupancy Q1 2024, 2-year design and construction schedule



B-EAST UPDATE



- \$10M has already been received
- Repair and replace damaged building components and equipment underway
- Repairs and gate delivery scheduled for fall 2022
- Amendment needed to add capacity to spend insurance dollars




PHASE 1 DS TAXIWAY – DE-ICE CAPACITY



- Budget \$24M
- Phase 1 of DS Taxiway will provide needed de-ice capacity
- Additional de-ice capacity needed by fall 2022
- 7 de-ice positions per FAA A/C 150/5300-13B
- Net add of 4 de-ice positions
- 24,000 square yards new airfield pavement
- Remove and replace mast lighting





GATE APRON REHAB





Budget \$45M

- Replaces deteriorated pavement and replaces/adjusts utilities
- Pavement and some utilities have reached the end of their design life
 Gate expansion phasing in 2022 will
 provide a unique opportunity to
 complete apron work while gates are not
 in service
- Will take place with the scheduled airline
 relocation work to minimize operational
 impacts and provide potential cost
 efficiencies

SUSTAINABILITY AND LEED STATUS



- Program goal is to achieve LEED v4 Gold certification
 - Gate Expansion B-West was awarded LEED Gold in 2021
 - B-East, C-East and A-West are on track for Gold Certification
- Rooftop photo-voltaic system
- Generate 10% of building demand
- Achieve 30% building energy demand reduction
- 40% reduction from interior lighting
- Energy recovery of exhaust air
- Water usage reduced 45%
- Building commissioning
- Sustainable materials
- Recycle materials



FUNDING SOURCES



- The A-East Ground Load (AEGL) and de-ice pad will be funded out of the next 5-year DEN CIP (2023-2027)
 - The AEGL will be bond financed and Passenger Facility Charges (PFCs) will be used to pay for the debt service costs
 - The de-ice pad will also be bond financed and the debt service costs will be recovered through airline landing fees









GATE EXPANSION PROGRAM AREAS







DEN is building 39 new concourse gates, increasing overall capacity at the airport by 30%. All three concourses are expanding to allow existing airlines the opportunity to grow and for DEN to accommodate new airlines, including international carriers.
